IMPORTANT RECALL INFORMATION

We are sending you information about Polymyxin B for Injection USP, 500,000 Units/Vial that may be valuable to you.

On January 26, 2022, AuroMedics Pharma LLC issued a recall of one lot of Polymyxin B for Injection USP, 500,000 Units/Vial. This recall was issued because hair was discovered in a vial within the affected lot, which could be a health hazard or safety risk to plan members using product affected by this recall.

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

This recall affects lot CPB200013 exp. 09/2022. To see if you have affected product, check the lot number. The lot number is located on the manufacturer's label. If your drug is not from lot number CPB200013, it is not affected by this recall. If you received any recalled product from your retail pharmacy, please contact the pharmacy that filled your prescription for more information including return instructions.

Auromedics recommends that consumers who have the product lot which is being recalled should immediately stop using and return to place of purchase. Please call your doctor right away for advice if you may be using affected product or if you do not know if you used affected product. Your doctor is familiar with your medical history and can suggest the best treatment option for you. If you need a prescription for a different medicine, please contact your doctor.
