## IMPORTANT RECALL INFORMATION

We are sending you information about Magnesium Citrate Saline Laxative Oral Solution that may be valuable to you.

On July 25, 2022, Vi-Jon issued a recall of Magnesium Citrate Saline Laxative Oral Solution manufactured by Vi-Jon, LLC. This includes all lots of Lemon, Cherry and Grape flavor of Magnesium Citrate Saline Laxative Oral Solution, 10 FL OZ (296 mL) within expiry. This recall was issued due to testing showing the presence of abnormal bacteria in the product.

Our records show you may have received a prescription for this medicine recently from your retail pharmacy:

According to Vi-Jon, immunocompromised patients who consume this product may be at increased risk for invasive infections caused by Gluconacetobacter liquefaciens that could lead to serious, life-threatening adverse health consequences. Vi-Jon has advised that, to date, it is aware of 3 (three) reports of serious adverse reactions potentially related to this recall. Vi-Jon, LLC has further advised that it is in the process of investigating these reports.

The product is used for relief of occasional constipation (irregularity) and generally produces bowel movement in  $\frac{1}{2}$  to 6 hours. The product is packaged in a 10 oz clear round plastic bottle.

If you received your product in a manufacturer's bottle, please check the NDC. The NDC number is located on the front of the box, top-left hand corner, or on the top-left-hand corner of the label on the bottle. If the product you have is not from one of these affected NDC numbers, it is not affected by this recall. If your product is from one of these affected NDC numbers, please contact the pharmacy that filled your prescription for further instructions.

Vi-Jon, LLC. is directing consumers using affected product to contact their healthcare provider and discontinue use. Please call your health care professional right away for advice if you may be using affected product or if you do not know if you used affected product. Your doctor is familiar with your medical history and can suggest the best treatment option for you.
