IMPORTANT RECALL INFORMATION

We are sending you information about Phytonadione Injectable Emulsion that may be valuable to you.

On April 8, 2020, the United States Food and Drug Administration (FDA) issued a notice regarding a voluntary recall of Phytonadione Injectable Emulsion manufactured by Dr. Reddy's Laboratories. **Dr. Reddy's issued this recall after receiving complaints of ampules breaking and shattering upon opening. This could pose a health hazard or safety risk to individuals who may be using product affected by this recall.**

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

A list of the affected products and lot numbers is provided at the end of this letter.

To see if you have affected product, please check the lot number. The lot number is located on the manufacturer's label on each vial under the bar code and on the manufacturer's carton. If your product is not from one of these affected lots, it is not affected by this recall. Please call your doctor right away for advice if you may be using affected product or if you do not know if you used affected product. Your doctor is familiar with your medical history and can suggest the best treatment option for you.
