IMPORTANT RECALL INFORMATION

We are sending you information about Ceftazidime for Injection USP and Dextrose for Injection that may be valuable to you.

On May 5, 2020, the United States Food and Drug Administration (FDA) issued a notice regarding a recall of Ceftazidime for Injection USP and Dextrose for Injection manufactured by B Braun. **This recall was issued because of failures in stability testing reflecting elevated levels of High Molecular Weight Polymers (HMWP), which could pose a health hazard or safety risk to plan members using product affected by this recall.**

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

This recall affects lot number H8J812, Exp. 07/31/2020. To see if you have affected product, please check the lot number. The lot number is located on the manufacturer's label above the bar code. If your product is not from lot number H8J812, it is not affected by this recall. If your product is from lot number H8J812, please contact your prescriber, who can advise you on the best treatment option for you.

Please call your doctor right away for advice if you may be using affected product or if you do not know if you used affected product. Your doctor is familiar with your medical history and can suggest the best treatment option for you. If you need a prescription for a different medicine, please contact your doctor. **B Braun advises that consumers should contact their physician or healthcare provider if they have experienced any problems that may be related to taking or using this drug product.**
