## IMPORTANT RECALL INFORMATION

On August 19, 2020, Bayshore Pharmaceuticals, LLC issued a recall of certain Metformin Hydrochloride Extended-Release 500 mg tablets and 750 mg tablets. **This recall was issued because an unexpected impurity was found in these products that could be a health hazard or safety risk to plan members using product affected by this recall.** 

Our records show you may have received a prescription for the following product recently from your retail pharmacy:

The United States Food and Drug Administration (FDA) recommends that consumers should continue taking metformin tablets even after recalls occur, until they consult with their health care professional who can prescribe a replacement. The FDA has advised that it could be dangerous for patients with type 2 diabetes to stop taking their Metformin without first talking to their health care professionals.

Please call your health care professional right away for advice if you may be using affected product or if you do not know if you used affected product. Your health care professional is familiar with your medical history and can suggest the best treatment option for you.
