IMPORTANT RECALL INFORMATION

We are sending you information about NP Thyroid® 15 mg and 120 mg tablets that may be valuable to you.

On September 18, 2020, Acella Pharmaceuticals, LLC issued a recall of NP Thyroid[®] 15 mg and 120 mg tablets. **This recall was issued because these tablets may be sub potent, which could be a health hazard or safety risk to plan members using product affected by this recall.** Sub potent means that the product contains less than the required amount of the active ingredient(s).

Patients being treated for hypothyroidism (underactive thyroid), who receive sub potent NP Thyroid®, may experience signs and symptoms of hypothyroidism (underactive thyroid) such as fatigue, increased sensitivity to cold, constipation, dry skin, puffy face, hair loss, slow heart rate, depression, swelling of the thyroid gland and/or unexplained weight gain or difficulty losing weight.

There is reasonable risk of serious injury in newborn infants or pregnant women with hypothyroidism including early miscarriage, fetal hyperthyroidism, and/or impairments to fetal neural and skeletal development. In both elderly and patients with underlying cardiac disease toxic cardiac manifestations of hyperthyroidism may occur, such as cardiac pain, palpitations or cardiac arrhythmia.
