We are sending you information about RIOMET ER™ 500 mg/5 mL that may be valuable to you.

On September 24, 2020, Sun Pharmaceutical Industries, Inc. issued a recall of one lot of RIOMET ER™ 500 mg/5 mL. This recall was issued because an unexpected impurity was found in these products that could be a health hazard or safety risk to plan members using product affected by this recall.

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

To see if you have affected drug, please check the lot number. The lot number is located to the right of the barcode at the bottom of the drug label. If your drug is not from this affected lot number, it is not affected by this recall.

The United States Food and Drug Administration (FDA) recommends that consumers continue taking metformin oral suspension even after recalls occur, until they consult with their health care professional for advice about alternative treatment. The FDA has advised that it could be dangerous for patients with type 2 diabetes to stop taking their Metformin without first talking to their health care professionals.
