IMPORTANT RECALL INFORMATION

We are sending you information about Sildenafil 100mg tablets and Trazodone 100mg tablets distributed by AvKARE that may be valuable to you.

On December 8, 2020, AvKARE issued recalls of Sildenafil 100mg tablets and Trazodone 100mg tablets. **This recall is due to mixed product being found in bottles of both products. AvKARE bottles labeled as Sildenafil 100mg tablets were found to contain Trazodone 100mg tablets and AvKARE bottles labeled as Trazodone 100mg tablets were found to contain Sildenafil 100mg tablets.**

Unintentionally taking sildenafil may pose serious health risks to consumers with underlying medical issues. For example, sildenafil may interact with nitrates found in some prescription drugs (such as nitroglycerin) lowering blood pressure to dangerous levels. Consumers with diabetes, high blood pressure, or heart disease often take nitrates.

Unintentionally taking trazodone may pose serious health risks such as somnolence/sedation, dizziness, constipation, and blurred vision. These adverse events may be more concerning in elderly patients due to a subsequent increased risk for falls and driving impairment.

Our records show you may have received a prescription for the following medicine recently from your retail pharmacy:

AvKARE's Sildenafil 100mg tablets are WHITE, OVAL-shaped, FILM-COATED TABLETS imprinted with TEVA on one side and 5343 on the other side.

AvKARE's Trazodone 100mg tablets are WHITE, ROUND-shaped, SCORED TABLETS imprinted with PLIVA 434.

If you received any tablets that do match the description of your intended product, do not use it and call your doctor right away for advice. Please contact the pharmacy that filled your prescription for more information including return instructions.
