## IMPORTANT RECALL INFORMATION

On December 28, 2020, Sunstar Americas, Inc. (SAI) issued a recall of Paroex® Chlorhexidine Gluconate Oral Rinse USP, 0.12%. This recall was issued because of a possible bacterial contamination in these products that could be a health hazard or safety risk to plan members using product affected by this recall.

Your doctor is familiar with your medical history and can suggest the best treatment option for you. If you need a prescription for a different medicine, please contact your doctor.
