### **IMPORTANT RECALL INFORMATION**

We are sending you information about Enoxaparin Sodium Injection that may be valuable to you.

On February 3, 2021, Apotex issued a recall of Enoxaparin Sodium Injection. **This recall was issued because the product was made with the wrong barrels of syringes. This could cause slightly higher doses of enoxaparin to be given to a patient.**

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

**A complete list of the affected products and lot numbers is provided at the end of this letter.**

To see if you have affected product, check the lot number. The lot number is on the manufacturer's label on the syringe and on back of the carton. If your drug is not from one of these affected lot numbers, it is not affected by this recall. If your drug is from one of these affected lot numbers, please contact the pharmacy that filled your prescription for further instructions.

**Apotex advises that consumers should not interrupt their therapy. Consumers should contact their health care provider for medical advice and obtain replacement therapy before returning impacted product.**

**Please call your doctor right away for advice if you may be using affected product or if you do not know if you used affected product or not.** Your doctor is familiar with your medical history and can suggest the best treatment for you. If you need a prescription for a different medicine, please contact your doctor.
