IMPORTANT RECALL INFORMATION

We are sending you information about Accuretic™ tablets as well as quinapril and hydrochlorothiazide and quinapril HCl/ hydrochlorothiazide that may be valuable to you.

On March 21, 2022, Pfizer issued a voluntary recall of Accuretic™ tablets distributed by Pfizer as well as quinapril and hydrochlorothiazide and quinapril HCl/ hydrochlorothiazide distributed by Greenstone. **This recall was issued because of a specific chemical impurity above the Acceptable Daily Intake (ADI) level.**

Our records show you may have received a prescription for the following medicine recently from your retail pharmacy:
