RECALL NOTICE

Our records indicate that you may have recently received a prescription for Lansoprazole Delayed-Release Capsules from your retail pharmacy. We are writing to inform you of a limited recall that has been issued for certain lot numbers of this product.

On March 31, 2022, the United States Food and Drug Administration (FDA) classified the recall of certain lot numbers Lansoprazole Delayed-Release Capsules manufactured by Dr. Reddy's Laboratories as a Class II recall. According to Dr. Reddy's Laboratories, this recall was issued due to out of specification results for long term stability testing. The manufacturer issued this recall on March 23, 2022 to wholesalers and pharmacies only. The manufacturer is not requiring any action on the part of consumers in this recall.

A list of the affected products is provided at the end of this letter.
