RECALL NOTICE

Dear <<First Name>> <<Last Name>>,

Our records indicate that you may have recently received a prescription for Lansoprazole Delayed Release Orally Disintegrating (ODT) Tablets manufactured by Dr. Reddy's Laboratories from your retail pharmacy. We are writing to inform you of limited recalls that have been issued for certain lot numbers of these products.

On July 23, 2022, the United States Food and Drug Administration (FDA) published its classification of the recalls of certain lots of Lansoprazole Delayed Release Orally Disintegrating (ODT) Tablets manufactured by Dr. Reddy's Laboratories, Class II recalls. According to the manufacturer, these products are being recalled due to out-of-specification results observed in dissolution test in one lot (T2100514) of the 15mg product during long term stability testing, and the second lot (T2100515, 30mg product) is also being recalled as a precautionary measure as it was manufactured from the same common blend as of the OOS lot (T2100514, 15mg product).

According to the manufacturer, due to higher dissolution results, the therapeutic concentration of the drug may fluctuate marginally during the day, but it may not alter the therapeutic benefit and is unlikely to cause any serious adverse effects to the patients consuming the subject lot (T2100514) and the other impacted lot (T2100515).

The manufacturer issued this recall on July 13, 2022 to wholesalers and pharmacies only. The manufacturer is not requiring any action on the part of consumers in this recall.
