IMPORTANT RECALL INFORMATION

We are sending you information about Xolair® 150 mg/1 mL Prefilled Syringe that may be valuable to you.

On June 9, 2021, Genentech issued a recall of Xolair® 150 mg/1 mL Prefilled Syringe. This recall was issued because the affected lots have an expiration date period that is shorter than expected, earlier than what is labeled on the box.

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

This recall affects lot numbers 3352758 expiration date 08/2021, and 3352759 expiration date 08/2021. No other lots are affected by this recall.

To see if you have affected product, please check the lot number. The lot number is located on the syringe next to the QR code on the label and on the product box. If your product is not from lot number 3352758 or 3352759, it is not affected by this recall. If your product is from lot number 3352758 or 3352759, please contact the pharmacy that filled your prescription for further instructions.

Genentech advises that:

- 1. Consumer should not use Xolair® prefilled syringes from lot number 3352758 or 3352759.
- **2. Get a replacement:** Contact the pharmacy or doctor's office who gave the Xolair® prefilled syringe to you for further instructions on how to receive a replacement free of charge.

Please call your doctor right away for advice if you may be using affected product or if you do not know if you used affected product or not. Your doctor is familiar with your medical history and can suggest the best treatment for you. If you need a prescription for a different medicine, please contact your doctor.
