IMPORTANT RECALL INFORMATION

We are sending you information about Clobetasol Propionate Ointment, 0.05% that may be valuable to you.

On December 30, 2021, the United States Food and Drug Administration (FDA) published a notice regarding a voluntary recall of one lot of Clobetasol Propionate Ointment, 0.05% NDC #51672-1259-03 manufactured by Taro Pharmaceuticals USA. This recall was issued due to the presence of bacteria that may cause an infection.

Our records show you may have received a prescription for this medicine recently from your retail pharmacy.

This recall affects lot number AC13786 exp. 12/2022.

To see if you have affected product, please check the lot number. The lot number and expiration date are displayed on the bottom of each tube and on the end flap of the product carton. If the product you have is not from the affected lot number, it is not affected by this recall. If your product is from the affected lot number, please contact the pharmacy that filled your prescription for further instructions.

Taro has advised that consumers should contact their physician or healthcare provider if they have experienced any problems that may be related to taking or using this drug product. Please call your health care professional right away for advice if you may be using affected product or if you do not know if you used affected product. Your doctor is familiar with your medical history and can suggest the best treatment option for you.
