7.4E.(3) construct to a height of six and a half feet.

PLANNING OVERVIEW

The applicant is proposing to construct two (2) incidental ground signs (pre-menu board and real time digital order screen) for the Starbucks Restaurant. The pre-menu board is requested to be 12 square feet and approximately 6.5 feet tall. The digital order screen is requested to be approximately 10 square feet and attached to 10 foot by 4.5 foot structure with 6 foot by 4.5 foot canopy overhang.

The requested placement is on the west side of the building (the Quaker Boulevard frontage). The site has approximately 224 lineal feet of frontage along Quaker Boulevard. The requested signs are setback approximately 40 feet from the Quaker Boulevard right of way. They are not intended or designed to be visible or draw attention from the roadway. The applicant has stated that the only time the digital order screen will be on is during the order period, all other times it will be "idle" or off and not in use, a blank screen.

STAFF COMMENTS, QUESTIONS AND CONCERNS

Article 7.4E.3. Maximum Sign Surface Area of Incidental Signs

Incidental signs shall not exceed six square feet in sign surface area per sign.

Article 7.4E.6. Maximum Height of Incidental Signs.

The maximum height of an (Incidental) Ground Sign Shall be four (4) feet in height above Grade except in all Industrial Districts where the maximum height of a Ground Sign shall be seven (7)

Attached to this report are photos of the signs on site. They were installed about a month ago. This was brought to the attention of the applicant at that time. The applicant expressed apologies and has agreed to remove immediately should the Board of Zoning appeals require. The photos do provide interested parties the opportunity to see the actual representation of the requests.

MOTION

I move that the Board of Zoning Appeals **approve / deny / continue** BZA-21-060, as filed by Hilton Displays for Starbucks, requesting a Variance to the Development Standards to allow two 6.5 foot tall incidental ground signs (menu boards) at 5050 Cambridge Way. If approved subject to the following conditions:


- 1. The approval will not / will be injurious to the public health, safety, morals, and general welfare of the community:

- 3. The strict application of the terms of the zoning ordinance will / will not result in practical difficulties if applied to the property for which the variance is sought;


And that such approval shall be subject to the following condition(s):


- 1. The only time the digital order screen will be on is during the order period, all other times it will be "idle" or off and not in use, a blank screen.

- 3. Submittal of application for Improvement Location Permit for signage.




