Part of the Southwest Quarter of Section 5 and the Southeast Quarter of Section 6, both in Township 14 North, Range 2 East of the Second Principal Meridian in Hendricks County, Indiana, being that 87.252 acre tract of land shown on the plat of an ALTA/NSPS Land Title survey of said tract certified by Chandler A. Harden, PS #LS22300025 on _____, 2026 as Banning Engineering's project number 26098 (all references to monuments and courses herein are as shown on said plat of survey) described as follows:

Commencing at a railroad spike marking the southeast corner of the Southwest Quarter of said Section 5; thence North 00 degrees 52 minutes 16 seconds West along the east line of said Southwest Quarter a distance of 140.99 feet to the POINT OF BEGINNING, said point being on the north line of the land of the Town of Plainfield as described in Instrument Number 202418882 in the Office of the Recorder of Hendricks County (the following seven (7) courses are along the north lines of said land of the Town of Plainfield; 1) thence South 22 degrees 25 minutes 40 seconds West 86.03 feet; 2) thence South 83 degrees 02 minutes 56 seconds West 341.32 feet; 3) thence South 88 degrees 02 minutes 03 seconds West 556.03 feet; 4) thence South 88 degrees 02 minutes 03 seconds West 389.96 feet; 5) thence South 88 degrees 02 minutes 35 seconds West 734.09 feet; 6) thence North 40 degrees 37 minutes 00 seconds West 32.02 feet; 7) thence South 67 degrees 17 minutes 50 seconds West 50.37 feet to the centerline of Guilford Branch; thence North 54 degrees 05 minutes 29 seconds West along the centerline of said Guilford Branch 968.92 feet to the south limited access right of way line of Interstate 70 (the following four (4) courses are along said south line); 1) thence North 60 degrees 22 minutes 10 seconds East 36.18 feet to a 5/8-inch rebar with cap stamped "Schneider"; 2) thence North 49 degrees 06 minutes 38 seconds East 154.74 feet; 3) thence North 59 degrees 54 minutes 38 seconds East 1,633.42 feet to a point on the east line of the West Half of the Southwest Quarter of Section 5, said point being witnessed by a 5/8-inch rebar found 1.40 feet southwest; 4) thence North 60 degrees 24 minutes 38 seconds East 1,388.51 feet to the west line of a 1.088 acre exception as described in Instrument Number 201526551 (the following four (4) courses are along the west and east lines of said exception; 1) thence South 05 degrees 34 minutes 11 seconds East 496.20 feet; 2) thence South 07 degrees 27 minutes 48 seconds East 452.71 feet to a 5/8-inch rebar; 3) thence North 01 degree 45 minutes 33 seconds West 50.00 feet; 4) thence North 01 degree 10 minutes 10 seconds West 938.75 feet; thence North 88 degrees 48 minutes 50 seconds East 16.00 feet to the east line of the Southwest Quarter of said Section 5; thence South 00 degrees 52 minutes 16 seconds East

along said east line 2,064.87 feet to the POINT OF BEGINNING, containing 87.252 acres, more or less.
