

- 4. I/We will assure that all passengers and participants in our watercraft have signed this waiver, release and indemnification of liability.
- 5. I/We understand children on boats MUST WEAR life vests during the Activity.
  6. ASSUMPTION OF RISK. THERE ARE RISKS INHERENT IN THE ACTIVITY, AND I/WE FREELY ASSUME ALL RISKS, INCLUDING PERSONAL INJURY OR DEATH TO MYSELF AND MY CREW, LOSS OR DAMAGE TO MY VESSEL AND ITS EQUIPMENT, AS WELL AS UNFORESEEN RISKS.
- 7. WAIVER, RELEASE AND INDEMNIFICATION.
