**I worked with Attorney Ekuia Assibill (black female) in a case where she told me to lie. A judge asked me in 2018 if I was present and I answered honestly "no". The judge said he couldn't sign the document, so Ms. Assibill was upset. She said she would look for a judge who would sign it. Lt. Wolfe knew that Ms. Assibill was harassing me for not signing the document. Lt. Wolfe did nothing to stop the hostility from Ms. Assibill.**

**On January 9, 2020 Ms. Assibill filed a complaint against me. I was accused of lying. I instructed the Respondent to download my phone calls. They did download the phone. There was no evidence of a phone call with the Lab Tech. I was interrogated for four hours. I was suspended on this same day, January 17, 2020. Dir. David Maxwell told me I couldn't leave. I was interrogated by Mr. Chris Smith. I was cleared on this incident. He said I could resign. I was given until February 4, 2020 to give them my decision. They took my commission away because of "low productivity". During the intake interview with the EEOC Major Anderson called me. He left a voice message asking me to call him back about my decision. White males in my department are allowed to transfer. I requested to transfer, but I was denied. As for my low productivity, no white male in my department was discharged for that reason. Mr. Maxwell knew that I had two years to file a lawsuit against the male who blew kisses at my breast. The time limit expired December 2019.**

**I believe that I am being discriminated against, because of my national origin (Hispanic), sex (female) and retaliated against, in violation of Title VII of the Civil Rights Act of 1964, as amended.**
