NARRATIVE	BODYWORN CAMERA EVENT #10700. IN SUMMARY, ON 15SEP21 AT 1620 HOURS, I RESPONDED TO A CALL OF AN ARTMED CAR JACKING AT THE ADDRESS OF 16 N. CLARK STREET. I LEARNED VIA OEMC THAT A GRAY AUDI Q8 SUV HAD BEEN HIJACKED AT GUN POINT BY TWO MALE BLACK OFFENDERS, ONE WEARING A WHITE T-SHIRT AND ONE WEARING ALL BLACK. ONE OFFENDER WAS SIX FEET TALL 170LBS AND THE OTHER WAS BETWEEN FIVE FOOT NINE AND FIVE FOOT TEN, BETWEEN TWO HUNDRED TO TWO HUNDRED TWENTY POUNDS. THE VEHICLE WAS LAST SCENE NORTH BOUND ON CLARK STREET FROM NORTH AVE. I BEGAN TO TOUR THE AREA AROUND ARMITAGE AND CLARK STREET TO FULLERTON AVE WITH NEGATIVE RESULTS OF THE VEHICLE. I THEN RELOCATED TO THE ADDRESS OF OCCURANCE AND SPOKE TO THE VICTIM RELATED THE LISTED OFFENDERS DESCRIPTION THAT HE GAVE OEMC. BEAT 5706D IN COORDINATION WITH BEAT 5700A WERE ABLE TO LOCATE THE LAST LOCATION OF THE VEHICLE VIA LPR HIT WHERE IT WAS LAST SEEN AT 71ST STREET AND THE DAN RYAN GOING SOUTH BOUND IN LANE 5. BEAT 5700A FURTHER RELATED THAT THE STOLEN AUDI HAD A CHASE VEHICLE INVOLVED WITH IT BEARING ILLINOIS REGISTRATION PLATE OF # WHICH YIELDED A WHITE 2019 VOLVO UTILITY STOLEN OUT OF BERWYN ILLINOIS. VICTIM THEN RELATED FURTHER INFORMATION TO ME: WAS SITTING IN THE FRONT PASSENGER SEAT WITH THE IGNITION ON, PUTTING A STICKER IN HIS FRONT WINDSHIELD WHEN TWO UNKNOWN MALE BLACK OFFENDERS APPROACHED SAYING ?GIVE ME THE FUCKING CAR? WHILE ONE DISPLAYED A BLACK HANDGUN. COMPLIED WITH THEIR DEMAND OF THE VEHICLE AND THE VEHICLE FLED NORTHBOUND ONTO CLARK STREET. I GAVE A VIN AND CONTINUED TO TOUR THE AREA FOR THE VEHICLE. VEHICLE ENTERED INTO LEADS AS A STOLEN VEHICLE BY SANDERS #21. THE INCIDENT WAS RECORDED ON POD CAMERA 4027W. THERE ARE ALSO SECURITY CAMERAS PRESENT
