2. PRICES

Prices are subject to change without notice. Prices are as shown on the website (www.jrbsilks.com) or as quoted to you by JRB Silk Fabrics, LLC and price quotes do not include all applicable taxes and shipping and handling charges unless specified.

3. TERMS OF PAYMENT

Terms of payment are credit cards, checks or net 30 unless otherwise agreed.

4. ORDER CANCELLATION

Orders can only be cancelled prior to shipment. You are responsible for any applicable charges in case of cancellation.

5. RISK OF LOST DELIVERY
