Project 58 receives all food items in good faith, and we ask that our members give in good faith to those who need it. Items received may not be sold, bartered, or traded for a profit. This is punishable by law.

- May not be used for fundraisers, flea markets, thrift store sales or food share cooperative programs.

The policy of WAIO is to aggressively protect its food donors from the downstream sale, barter or exchange of donated items. We expect our outreach partners and their associated agencies to abide by this policy and to report partners and/or agencies that do not comply.

WAIO takes such reports very seriously. All reports are investigated and appropriate action is taken regarding any partner who barter, sells or exchanges donated product, to include the elimination of any such partner from the distribution list of WAIO.

Partnering organizations should realize that violation of this policy can result in companies no longer donating food and relief supplies to WAIO.
