

Fund for Workforce Equity Selects Inaugural Grantees

\$1 million awarded to workforce organizations from across the country to center workers and learners of color

(November 17, 2022) – The [Fund for Workforce Equity](#), a new pooled investment fund led by Workforce Matters, announced 15 grant recipients that will each receive grants of up to \$75,000 to implement initiatives that center workers and learners of color in designing or implementing workforce policies and programs. The grantees, workforce development organizations from across the country, will receive flexible resources and support to pilot, innovate, or extend strategies.

"These 15 organizations are leaders in centering workers to drive equity in workforce development efforts. We want to provide funding and support to expand their work and uplift new, innovative strategies that can lead to systemic change," said Loh-Sze Leung, director of Workforce Matters.
