This privacy statement outlines what information/personal data is collected from you and how that information is handled by Mindful Talent Coaching Academy in accordance with the General Data Protection Regulation 2016 (GDPR).

USE OF INFORMATION

As a general policy, no personally identifiable information ("PERSONAL DATA"), such as your name, address, or e-mail address, is *automatically* collected from your visit to the SITE. Any personal data collected must be voluntarily entered by you.

Non-personal data is recorded by the standard operation of Mindful Talent Coaching Academy internet servers. Information such as the type of browser being used, its operating system, and your IP address is gathered to enhance your online experience.

For example:

- Mindful Talent Coaching Academy has the standard Facebook pixel installed for analytics about which site and/or landing pages a user visits to help improve and provide feedback regarding which pages are visited
- Mindful Talent Coaching Academy receives updates from Google Analytics and LinkedIn on which pages are visited.

Personal Data is information that specifically identifies you (name, email address, ship to/bill to address, phone number) and can be used to specifically locate you from within the Mindful Talent Coaching Academy database and/or filing system.

The Company's various mailing lists, downloads, special offers, contests, registration forms, and surveys may request that you provide contact information such as your

- Name
- Email
- Address
- Telephone Number

Information submitted at the time of submission will be used by Mindful Talent Coaching Academy to:

- Email you the requested information from Mindful Talent Coaching Academy;
- Email you a time-specified newsletter (e.g. fortnightly/monthly, dependent on which product or course you have subscribed to) from Mindful Talent Coaching Academy
- Provide access to requested offers, promotions or products.
- Provide updates and additional information in relation to the course/product you have subscribed to.
- Inform you of any new promotions offers/opportunities

Personal Data submitted voluntarily by you is held within the Mindful Talent Coaching Academy Kajabi site and database;

- Until you request to be unsubscribed and /or up to two years from the time of submitting, whichever
 comes sooner. Before removal Mindful Talent Coaching Academy will ask you to confirm that he or she
 wants to remain within the database.
- Based on the contractual relationship between Mindful Talent Coaching Academy and you Mindful
 Talent Coaching Academy will delete and destroy your information following the end or termination of
 the contractual period.
- Mindful Talent Coaching Academy will maintain all legal records for the time period required by law.
 For example: transactions required by tax laws must be kept for 7 years.

LEGAL BASIS FOR USE OF INFORMATION

Mindful Talent Coaching Academy is legally processing your data based on one or more of the following:

- You have given your explicit and voluntary consent to Mindful Talent Coaching Academy.
- You have a contract with the Mindful Talent Coaching Academy that necessitates the company having your personal data.
- Mindful Talent Coaching Academy has a legal obligation that requires processing your personal data.

USE OF THIRD PARTIES

Personal Data is never sold, leased, or shared with any third parties without your explicit consent. (A third party is a company outside of your relationship with Mindful Talent Coaching Academy)

USE OF CREDIT CARD INFORMATION

Mindful Talent Coaching Academy does not store any credit card information it may receive regarding a specific transaction and/or billing arrangement except as necessary to complete and satisfy its rights and obligations about such transaction, billing arrangement, and/or as otherwise authorized by a user.

All credit card information is handled by Stripe and PayPal.

USE OF LEGAL OBLIGATIONS

Mindful Talent Coaching Academy may disclose your information in special cases when required by legal and or law enforcement and *only* when required by law.

If the Mindful Talent Coaching Academy has reasonable reason(s) to believe that disclosing Personal Data held by us is necessary to identify, contact or bring legal action against someone who may be causing injury to or interference (either intentionally or unintentionally) with the Mindful Talent Coaching Academy rights or property, other users of our products and services, and or anyone else that could be harmed by such activities, then Mindful Talent Coaching Academy will work with the appropriate and legitimate law enforcement and or legal authorities to make sure that the Personal Data is handled in accordance with the applicable laws.

SUBCRIBERES RIGHTS

As a subscriber and or user of Mindful Talent Coaching Academy's products and/or services, you have the following rights:

- Transparent information from Mindful Talent Coaching Academy regarding how we communicate and interact with you;
- The right to hear back from Mindful Talent Coaching Academy regarding any inquiry into your Personal Data.
- To request correction of Personal Data from Mindful Talent Coaching Academy;
- Access to your Personal Data including knowing the purposes that the data is used for;
- To request erasure from Mindful Talent Coaching Academy records if there are no overriding legal, public interest, or legitimate interests;
- To a restriction on the processing of the Personal Data

- To object to processing of Personal Data Mindful Talent Coaching Academy shall no longer process your Personal Data unless Mindful Talent Coaching Academy demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims.
- To file a complaint with the supervisory authority (Association for Coaching or Institute of Leadership and Management, dependent on which course you have subscribed to)
- The right to unsubscribe at any time (withdraw consent)

PROFILING PERSONAL DATA

Profiling means any form of automated processing of Personal Data consisting of the use of Personal Data to evaluate certain personal aspects relating to a subscriber, to analyse or predict aspects concerning that subscriber's performance at work, economic situation, health, personal preferences, interests, reliability, behaviour, location or movements; Mindful Talent Coaching Academy does not engage in any sort of profiling of its subscribers based on Personal Data.

CHILDREN UNDER THE AGE OF 13

Mindful Talent Coaching Academy recognises the special obligation to protect Personal Data obtained from children age 13 and under.

In these instances, Parental/carer consent would be sought and, where applicable, the referring agency would demonstrate appropriate duty of care regarding consent.

USE OF COOKIES

Cookies are pieces of information that a website transfers to an individual's computer hard drive for record keeping purposes. *Cookies make using a website easier by saving your passwords and preferences for you.*

These cookies are restricted for use only on Mindful Talent Coaching Academy's website and do not transfer any Personal Data to any other party. Most browsers are initially set up to accept cookies.
