Conclusion: This study found large variations in the observed rates of AESIs by age group and sex, showing the need for stratification or standardisation before using background rates for safety surveillance. Considerable population level heterogeneity in AESI rates was found between databases.

Overall, 43 female patients were excluded. Among the remaining 120 patients, 30 were diagnosed as having definite vaccine-related symptoms, and 42 were diagnosed as probable. Among these 72 patients, the age at initial vaccination ranged from 11 to 19 years (average  $13.6 \pm 1.6$  years), and the age at appearance of symptoms ranged from 12 to 20 years (average  $14.4 \pm 1.7$  years). The patients received the initial human papillomavirus vaccine injection between May 2010 and April 2013. The first affected girl developed symptoms in October 2010, and the last two affected girls developed symptoms in October 2015. The time to onset after the first vaccine dose ranged from 1 to 1532 days (average  $319.7 \pm 349.3$  days).

+Although the use of a noninfectious pseudovirus is a limitation to this study, our data reveals that the **spike protein alone can damage endothelium**, manifested by impaired mitochondrial function and eNOS activity but increased glycolysis. It appears that the spike protein in ECs increases redox stress which may lead to AMPK deactivation, MDM2 upregulation, and ultimately ACE2 destabilization.<sup>4</sup>

PAH (pulmonary arterial hypertension) is a serious disease without a cure that can affect males and females of any age including children. **The increased pulmonary vascular resistance in PAH results in right heart failure and subsequently death. Thus, it is important to consider the possibility that the SARS-CoV-2 spike protein produced by the new COVID-19 vaccines triggers cell signaling events that promote PAH, other cardiovascular complications, and/or complications in other tissues/organs in certain individuals (Figure 3).** We will need to monitor carefully the long-term consequences of COVID-19 vaccines that introduce the spike protein into the human body.

### **+Pfizer's 6 month blinded, placebo controlled human Covid vaccine Trial results [\(LINK\)](#)**

**-No reduction in Death** (15 overall deaths in vaccine group, 14 in unvaxxed group – out of over 21,000 participants)-

**-Reduced Severe Disease in .1%** (respiratory, heart , neurologic symptoms..etc (.0004% chance vaxxed vs .134% chance unvaxxed)

**-Reduced “cases’ in 3.6%** (case= symptom pr positive test) (.364% chance in vaxxed vs 3.924% chance in unvaxxed)

**-Increased severe health issue in .5%** (1.194% chance in vaxxed vs .684% chance unvaxxed)

## **Absolute risk reduction vs. relative risk reduction**

These have the same numerator, different denominators. Let X be the number of cases that would occur under the treatment, Y be the number of cases that would occur under the control, and Z be the number of people in the population. The relative risk reduction (which is what we usually see) is  $(Y - X)/Y$  and the absolute risk reduction is  $(Y - X)/Z$ . So, for example, if  $X = 50$ ,  $Y = 1000$ , and  $Z = 1$  million, then the relative risk reduction is 95% but the absolute risk reduction is only 0.00095, or about a tenth of one percent.

ARR is also used to derive an estimate of vaccine effectiveness, which is the number needed to vaccinate (NNV) to prevent one more case of COVID-19 as  $1/ARR$ . NNVs bring a different perspective: 76 for the Moderna–NIH, 78 for the AstraZeneca–Oxford, 80 for the Gamaleya, 84 for the J&J, and 117 for the Pfizer–BioNTech vaccines. The explanation lies in the combination of vaccine efficacy and different background risks of COVID-19 across studies: **0.9% for the Pfizer–BioNTech, 1% for the Gamaleya, 1.4% for the Moderna–NIH, 1.8% for the J&J, and 1.9% for the AstraZeneca–Oxford vaccines.**

### **8.4 unknown risks/ data gaps**

- safety in certain subpopulations – currently insufficient data to make conclusion about safety of the vaccine in subpopulation such as children less than 18, pregnant and lactating individuals and their infants, and immunocompromised individuals.
- adverse reactions are very uncommon or that require longer follow up to be detected
- vaccine enhanced disease
