The United States government is in interregnum, and I am exercising the voice and vote of the US representatives on the Board of Governors and Board of Executive Directors of the World Bank and IMF until the Constitution of 1789 is reinstated pursuant to the provisions of Article V thereof.

I am providing copies of this correspondence to the relevant police authorities and to the New York missions and Tokyo embassies. The Global Debt Facility has notified the Securities and Exchange Commission of the interim financial statements of the Global Debt Facility, as well as the unlimited power of attorney over Allied Barton which I exercise on behalf of the Global Debt Facility. Any Allied Barton employee who prevents my full and unhindered access to the World Bank and IMF is hereby subject to immediate termination without further ado.

As agreed during the World Bank and IMF Annual Meetings, these arrangements on behalf of the Global Debt Facility are authorized by the countries copied on this email, unless they register their dissent in writing.
