The Villain

Let me introduce the villain of our story. It is the Bankers. The Bankers are very well organized. In fact, they are directed by the Black Nobility. The Black Nobility tell the rulers of every single country what to do. The Black Nobility are old families who stretch back generations, and are descended from the Pharaohs. The bloodline Pharaonic families were the Templars during the 30 years war between 1618 until 1648. Its preparations are concealed, not published. Its mistakes are buried not headlined. Its dissenters are silenced, not praised. No expenditure is questioned, no rumor is printed, no secret is revealed.”



The Coalition for the Rule of Law

I am a lawyer and economist who worked in the World Bank's Legal Department for 21 years. I reported corruption and was fired in 2007 as a whistleblower. I bought a World Bank bond, and sued the World Bank, its auditors KPMG, as well as a lawfirm that was supposed to evaluate my whistleblower claims, and the World Bank's medical insurer. The Board of Governors settled my lawsuit, and I was reinstated by the Board of Governors. This Coalition for the Rule of Law includes the members of the US military that are loyal to their oaths of office, as well as other countries' militaries that are loyal to the people in their countries. This Coalition is preserving the world's wealth that José Rizal deposited with the World Bank at the end of WWII. You can see the comments from the Coalition for the Rule of Law in my social media. In the last page of the teleprompter, I am showing you comments from the Coalition for the Rule of Law.

A critical mass of people are now fighting the Banking Cartel and the Black Nobility at its center. They say that a picture is worth a thousand words, so I want to show you a picture and describe it. This battle has many fronts: the Banking Cartel is trying to destabilize and starve us with country debt. But country debt is a scam because the Bankers owe us more money than we owe them. This is because the Bankers issued Treaty of Versailles bonds in the 1930's in exchange for the gold owned by the elites. These bonds have compounded interest, so that the bankers owe us more than 2 quadrillion dollars. This offsets country debt.



The picture shows the 99 percenters, up the creek without a paddle, and the one percent bankers driving away, whistling. Actually, the situation is just the reverse. The Bankers want you to believe they are winning, based on paper money which they issue. The real money is gold. The gold is all with us, in the Global Debt Facility. The Bankers are actually desperate, and making stupid mistakes.

Another front is the attempt to start WWII in Syria. A critical mass of people in the military know about the corruption and that the Bankers are using false flag operations, like the one in Syria, trying to start WWII. The title of our segment on April 17 was, "Bankrupt Banking Cartel and False Flag in Syria"



Steven Mnuchin is just play acting. This is because the Bankers tried to turn the US into a corporation. That is what they tried to do with all of the other countries in the world.



So I am saying that the United States depends on its monetary gold reserves to honor its commitment to defend Germany and that Trump does not have access to these gold reserves because he is an imposter. One of the rules of storytelling is that you should not pretend that you have never had to struggle. I am telling you that I am on the front lines, and that I sometimes have to struggle. The Banking Cartel tried to kill me in August 2016 during a family vacation in Canada. RE: Concerning Criticism of the Warren Report

1. **Our Concern.** From the day of President Kennedy's assassination on, there has been speculation about the responsibility for his murder. Although this was stemmed for a time by the Warren Commission report, (which appeared at the end of September 1964), various writers have now had time to scan the Commission's published report and documents for new pretexts for questioning, and there has been a new wave of books and articles criticizing the Commission's findings. In most cases the critics have speculated as to the existence of some kind of conspiracy, and often they have implied that the Commission itself was involved. Presumably as a result of the increasing challenge to the Warren Commission's report, a public opinion poll recently indicated that 46% of the American public did not think that Oswald acted alone, while more than half of those polled thought that the Commission had left some questions unresolved. Doubtless polls abroad would show similar, or possibly more adverse results.

2. This trend of opinion is a matter of concern to the U.S. government, including our organization. The members of the Warren Commission were naturally chosen for their integrity, experience and prominence. They represented both major parties, and they and their staff were deliberately drawn from all sections of the country. Just because of the standing of the Commissioners, efforts to impugn their rectitude and wisdom tend to cast doubt on the whole leadership of American society. Moreover, there seems to be an increasing tendency to hint that President Johnson himself, as the one person who might be said to have benefited, was in some way responsible for the assassination.

I have told you about the villain in our story first, to help you understand reality. The good guys are a coalition of people who are resisting the Banking Cartel. This coalition is stronger than the Banking Cartel, and was predicted with 90-95% certainty by a power transition model that came to me in 2004 from the US National War College. <https://s3.amazonaws.com/khudes/sentia+model.pdf>
