KRISPY KREME® GOLDEN DOZEN GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ENTER AT PARTICIPATING KRISPY KREME® STORES OR BY MAIL. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. **OVERVIEW:** The Krispy Kreme® Golden Dozen Giveaway (the "Giveaway") begins inside participating Krispy Kreme® stores in the 50 United States and D.C. (the "Territory") beginning on March 15, 2019, and ending on March 17, 2019 (the "Giveaway Period"). Participants may also enter, without a purchase, by mailing an entry to Krispy Kreme during the Giveaway Period. Void where prohibited or restricted by law. By participating in the Giveaway, each participant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Krispy Kreme Doughnut Corporation (the "Sponsor"), which shall be final and binding in all respects.
- 2. ELIGIBILITY: Open only to legal residents of the Territory who are at least eighteen (18) years of age. Persons in any of the following categories are NOT eligible to participate or win prizes in the Giveaway: any person who on or after February 15, 2019, was or is: (a) a Krispy Kreme store franchise owner or employee; (b) a director, officer, employee, agent, or independent contractor of Sponsor, or its parent company, subsidiaries, affiliates or service agencies; or any entities retained by Sponsor for the administration of the Giveaway; and (c) an immediate family member (defined as spouse, IRS dependent, or biological, adoptive or stepmother, father, sister, brother, daughter or son, and each of their respective spouses) of, or who resides in the same household as, any person in any of the preceding categories. Void outside the Territory and where prohibited or restricted by law.
- **3. ENTRY PERIOD:** The Giveaway will run during Krispy Kreme store opening hours at participating locations beginning on March 15, 2019, and ending on March 17, 2019 (the "Giveaway Period"). Participants entering via the mail-in option must have their entries postmarked between March 15, 2019, and March 17, 2019, and be received by Sponsor no later than March 24, 2019.
- **4. ENTRY:** There are two ways to enter.

<u>To Enter With Purchase / Store Entry Option</u>: During the Giveaway Period, participants must visit a participating Krispy Kreme® location, make a purchase of any amount and receive a receipt. Potential prize winners will be randomly selected and the receipt will advise participants if they are a potential prize winner.

<u>To Enter Without Purchase / Mail-In Option</u>: During the Giveaway Period, participants wishing to enter without making a purchase must send a 3" x 5" card with the following handwritten information: first and last name; mailing address; email address; age; and home or cellular telephone number. Mail the entry to Krispy Kreme Golden Dozen

Giveaway, Krispy Kreme Doughnut Corporation, 2116 Hawkins Street, Charlotte, NC 28203. All mailed entries must be legible and postmarked between March 15, 2019, and March 17, 2019, and received by Sponsor no later than March 24, 2019. Limit of one entry per envelope. Each time a 3" x 5" card is received, the member will earn one chance to win.

All entries become the sole and exclusive property of Sponsor and will not be acknowledged or returned. By entering the Giveaway, you agree and acknowledge that Sponsor may contact you via email or telephone. You further agree and acknowledge that such communication shall not be considered to be unsolicited commercial email or "spam." Sponsor is not responsible for illegible, incomplete, or stolen entries. By entering the Giveaway, you also agree and acknowledge that if you win, Sponsor may request, and you will provide, your postal address for purposes of sending your prize to you. Potential winners may be subject to verification of eligibility by Sponsor, whose decisions are final and binding in all matters related to this Giveaway. Award of the prizes will be subject to such verification.

5. WINNER SELECTION AND PRIZE: Each day during the Giveaway Period, participants at participating Krispy Kreme stores who make a purchase that generates a receipt will be randomly selected as a potential prize winner. In order to claim the prize and become a prize winner, the potential prize winner must provide to a designated Krispy Kreme store employee his or her first and last name; mailing address; email address; age; and home or cellular telephone number. If a potential winner chooses not to provide this information, the potential prize winner forfeits the prize and an alternate potential winner will be selected. At least one prize will be given away at each participating Krispy Kreme store during each day of the Giveaway Period.

In addition, on or about March 25, 2019, Sponsor will randomly select winners from all eligible mail-in entries submitted during the Entry Period. There will be as many Prizes available to those who enter through the Mail-In Option as were available for those who enter through the Store Entry Option. Potential winners that entered through the Mail-In Option will be notified via email or phone. If a potential winner cannot be contacted after twenty-four (24) hours, the potential winner forfeits the prize and an alternate potential winner will be selected. The prize will be sent to the winner by overnight delivery within two weeks after Sponsor receives verification and any requested information. It is the winner's obligation to notify Sponsor of any address changes; prizes returned as undeliverable will be forfeited.

PRIZE: The prize is a punch card (the "Prize Card") that entitles the owner to receive one dozen Krispy Kreme® Original Glazed® doughnuts per month for one year (total 12 dozen) at participating Krispy Kreme locations.
