KRAVIS CENTER'S PERSSON SOCIETY LUNCHEON HONORS ENDOWMENT SUPPORT FROM MEMBERS

(West Palm Beach, Fla.) Supporters of the Raymond F. Kravis Center for the Performing Arts gathered recently in the Center's Gimmelstob Ballroom for a special luncheon honoring members of the Helen K. Persson Society. Held on Wednesday, March 7, the event celebrated the Endowment supporters for their confidence, trust and investment in the Kravis Center's long-term future, which ensures that the cultural institution will be enjoyed for generations to come. Longtime supporters, Bernstein Private Wealth Management sponsored the luncheon for the ninth consecutive year.

Named for one of the Kravis Center's ardent supporters, the late Helen K. Persson, the Society now has 142 members. Helen's vision in support of the Center's future has been truly motivational."

Ms. Mitchell recognized Alexander Dreyfoos, the Kravis Center's Founding Chairman, for his leadership spearheading the fundraising campaign that exceeded all expectations to build the performing arts center. She also thanked and acknowledged members of the Board of Directors who were in attendance including immediate past Chair and current Vice Chair Jane Mitchell, Dr. Barbara Golden, Bradley Hurston, John Kessler and Richard Sloane.
