SUBJECT : Adoption and Implementation of the Guidelines on Enhanced Community Quarantine and Management of the Corona Virus Disease 2019 (COVID-19) Situation

With the exponential rise of confirmed COVID-19 cases in the region, the National Electrification Administration (NEA) endeavours to adopt, coordinate and implement the guidelines on the imposition of an Enhanced Community Quarantine and the Stringent Social Distancing Measures over the entire Luzon, including the National Capital Region (NCR), effective 00:00 (12 a.m.) of 17 March 2020 and expiring on 00:00 (12 a.m.) 13 April 2020 laid down in the Memorandum from the Executive Secretary of the Office of the President dated 16 March 2020 entitled: ***Community Quarantine Over the Entire Luzon and Further Guidelines for the Management of the Coronavirus Disease 2019 (COVID-19) Situation.***

As a strict home quarantine shall be observed in all households, the NEA Employees, Project Officers and workers of the Manpower Service Providers are advised to comply with the directive. Moreover, the work from home arrangement, which the NEA Employees have to adopt, is implemented immediately.

However, to sustain the role of this Office as the supervising agency of the ECs and attend to its stakeholders, NEA personnel in the Key Business Areas are expected to perform their respective identified Critical Functions to ensure its continued administrative functions and service delivery.
