Example of Draft Mentoring Plan


Schedule Initial Meeting – propose we meet for lunch this Wednesday (March 4)?

Determine frequency of "formal" contact: bi-weekly lunches; Determine best methods of communication: text followed by telephone call or meeting.

Decide what each party expects to invest in and receive from the mentor relationship: Duchess – xxxxx; Brian – xxxxx; Robin – Gain a better understanding of what newer lawyers need/what in order to improve our criminal law section mentoring program.

Discuss to what extent the conversations are to be kept confidential: any time one of the three of us requests that the information shared be kept confidential.

Determine methods of introducing the mentee to other members of the legal profession and assisting in the development of a network of informal career and person mentors: Brian will introduce Duchess to municipal court judges, staff, clerks and attorneys so that she gains more confidence in city court; and, Robin will introduce Duchess to the district and circuit court judges, staff, clerks, attorneys and professional service providers so that she gains more confidence in criminal court.
