PRACTICE OVERVIEW

Bradford S. Purcell defends individuals, public entities, and private companies of all types in civil litigation, particularly legal actions involving catastrophic injury and death. REPRESENTATIVE EXPERIENCE

Gone to verdict as lead trial counsel in federal court and state courts in Illinois, Indiana, and Michigan in cases involving wrongful death, traumatic brain injury, amputation, and catastrophic injuries. During a seven year stretch beginning in November 2011 alone, he went to verdict 10 times in cases that plaintiffs requested an aggregate of over \$128,350,000 in damages, achieving a defense verdict in all but two of the trials contesting liability.

- Served as lead trial counsel through verdict in a wide variety of cases, including trials involving construction accidents, commercial vehicle collisions, premises liability, product liability, and Section 1983 actions.
- Obtained summary judgments on behalf of general contractors in two separate construction accident cases involving catastrophic injury arguing lack of "retained control" pursuant to Section 414 of the Restatement (Second) of Torts.
- Achieved summary judgment in favor of municipalities in two separate cases, one involving alleged false imprisonment and false arrest, and the other involving alleged failure to maintain elevators at a correctional facility.
