"Debunking Five IRS and Tax Filing Myths

FROM THE OKLAHOMAN: Oklahoma tax lawyer, Travis Watkins warns taxpayers of the tax filing myths."

Thankfully, a tax expert can reveal how you can file complicated taxes successfully and how you should respond to further IRS interactions, Oklahoma City tax attorney Travis Watkins, winner of the Oklahomans' Readers' Choice Award for Best Taxation Attorney, broke down some of the most pervasive tax myths for us.

Myth: Filing taxes is voluntary, not required

Unpaid taxes can cause you a lot of headaches, but can it land you in jail? This myth is only true in certain situations, Watkins said. If you forget to file one tax return, the IRS is not likely to turn you over for criminal prosecution.

"The IRS does not put people into jail for paying their taxes or negligently forgetting to file their returns. The only time people may face a jail sentence is if they commit fraud (tax evasion, for instance) or willfully failing to file," Watkins said.

Although being a little late on filing a tax return is not a criminal issue, there are potential penalties, interest and late fees for unfiled returns and late payments, he added.

"If you owe over \$50,000, the IRS can request the State Department to take away your passport until matters are settled," Watkins explained. "Save yourself from worry and have a tax professional file taxes before due dates pass. Don't be part of the masses who financially imprison themselves with the IRS."

Myth: The IRS can only go back three years

Typically during an audit, the IRS reviews returns three years old or less, but if they suspect you of understanding your income by 20 percent or more, they will go back further.

"For instance, if your business earned \$100,000 and you only reported \$80,000, you didn't report 20 percent of your income, and as a result, the

Dealing with the IRS can be complex, confusing and downright scary. Misinformation runs past income tax returns. This is why we counsel rampant, making it hard to discern between IRS fact and fiction.

In cases where fraud is suspected, the IRS will go even further back in years to review returns. This time limit is placed only on tax returns that have been filed. If an audit concerns unfiled returns, the IRS will go back as far as necessary to figure out what is owed.

Myth: Oklahoma homestead Exemption law protects from IRS

"The U.S. taxation system is 'voluntary', but that doesn't mean that filing is optional," Watkins said. Voluntary in a tax-sense means that you are responsible for filing the correct amount of your own taxes each year. You are volunteering your tax information to the IRS. Once the IRS receives your information, they may review how much you owe. Refusing to volunteer your information can lead to a world of complicated paperwork, legal repercussion, and extra costs, he said.

Myth: You can go to jail for unpaid taxes

Unpaid taxes can cause you a lot of headaches,

Myth: If you owe the IRS money, the only option is a payment plan

You have options when dealing with tax debt. Payment plans can be set in place, but there are also penalty forgiveness programs available that can help reduce or eliminate penalties and interest. In cases where spouses have been duped into tax debt by their partners, a special spousal relief program is available, Watkins said.


You could also qualify for an Offer In Compromise. You could also qualify for an Offer In Compromise. Offers In Compromise are agreements that let you pay off tax debt for less than you owe by making payments on a reduced balance or settling for a reduced lump sum. You may also be able to qualify for a currently not collectible status. This status allows the IRS to put your account on hold and allows you to hold off making payments for a controlly 2 years. set time, generally 2 years.

Many people fo not know which programs are available to them when handling the IRS on their own and can easily land themselves in more trouble. Always review your specific case with a tax attorney to know your full list of options.

There are a number of options that Watkins Tax might be able to do to stop the IRS from taking money from your bank or paycheck.







"WHEN DEALING WITH THE IRS, SHOULD YOU REPRESENT YOURSELF?

FROM THE OKLAHOMAN: Oklahoma tax lawyer, Travis Watkins warns taxpayers about representing yourself."

Every year, thousands of people face an audit, levy, lien, or other collection effort by the Internal revenue Service (IRS), Dealing with the IRS is serious business. The average person doesn't know where to start when faced with a tax issue. Do you try to represent yourself, or do you seek the assistance of a professional tax attorney?

"You may think you can do it alone, but you may not fare as well as you initially think," said Travis Watkins, an Oklahoma City tax attorney. "We often get calls from folks that have tried representing themselves and it didn't go so well. You may think you have nothing to hide and the IRS employee may seem helpful, but without knowing any of your rights and privileges with the IRS and tax laws it can get complicated," he said. For instance, more than half the referrals to the IRS' Criminal Investigation Division are from IRS field auditors performing "routine audits," Watkins added. IRS agents are experts in understanding tax law, and the rights and powers that they possess. Audits and collection actions from the IRS begin with a written notice from the agency to the recipient, the taxpayer, Once a notice is received, the ball is in the taxpayer's court how to respond to and prepare for the proposed IRS action. "Usually, the IRS is demanding payment from you for a reason," Watkins said. "They use an automated computer system that creates and send collection notices," IRS notices may escalate in severity based on lack of action on the taxpayer's behalf. Certain notices open avenues for collection alternatives. No tax burden should be underrepresented, Watkins said.

Should you represent yourself?

"You probably are expecting that I will say, 'Abosolutely, you better hire an attorney'. Well, I'm here to tell you that may not be the case. There are some situations where you may do better with the IRS than having a representative." Watkins said. Some instances when it may be okay to represent yourself would be, if you have received a paper audit from the IRS asking to prove to them why a certain expense is valid or why your numbers don't match with their numbers, he said. "If you owe less than about \$2,500, it's probably not costeffective for you to hire an attorney or a tax representative in that case." Watkins said. There are, however, some situations in which you should hire a tax attorney. "You really don't want to handle payroll tax issues, for example, if you're a small or large employer," Watkins said. "You want to hire a representative, someone who works with the IRS every day, because the IRS is very severe when you owe payroll tax to the IRS. You want to be on a level playing field when in this situation," he added.

How does a tax attorney help?

The best defense against an industrious IRS employee is a tax professional who deals with IRS collections every day. A tax attorney, like Watkins, is trained to understand the tax as well as your rights when you owe or may owe under an IRS audit. "The first order of business is filing old tax returns," Watkins said. "My firm creates a customizable plan that we can execute, based on the master tax file the IRS keeps on every taxpayer." Additionally, a tax attorney can help stop immediate threats to taxpayer's livelihood, such as levies, liens, and seizures of property, Watkins said. "We hear across the board that because of tax problems, troubled taxpayers can't sleep at night," he said.
