WHAT HAPPENS IF MY SPOUSE FILED A JOINT TAX RETURN WITHOUT MY CONSENT?

In the vast majority of cases of jointly filed tax returns, both marital partners are on board with the information contained in the return and the fact that it is being filed. - Similarly, signing your name on the return without your consent is considered forgery, which is also a crime.
- If a joint return was filed without your consent, the IRS will automatically deem the non-consensual joint tax return to be fraudulent.
- If the IRS decides that your spouse filed the joint return intentionally and without your consent, he may face hefty financial penalties.
- In addition, if the IRS decides that your spouse filed the joint return intentionally and without your consent, your spouse may have to go to jail.
- If the non-consensual return is filed during a divorce proceeding, you may be entitled to relief from the family court in Oklahoma City or other courts that is handling your case.

Glamour Shots to Mug Shots

Internationally renowned Israeli swimsuit supermodel, Bar Refaeli, is once again in the legal hotseat after new allegations of suspected tax evasion has been brought not only against her, but her parents as well.

The 33-year-old swimsuit model, who in the past has graced the covers of prestigious magazines such as Maxim, GQ and Sports Illustrated, has been accused of tax evasion for not declaring income she earned abroad between the years of 2009 and 2012. According to the Israeli Justice Ministry, she failed to report over \$6.1 million to the Israeli Tax Authority over the course of this time period when she was living in the United States with then boyfriend, Leonardo DiCaprio.

Israeli authorities received a tip into her alleged schemes and an official investigation was launched against her. Over the course of two years, investigators used a tracking device to track her every move, which confirmed that she was earning income abroad, but was failing to report that income to the Israeli Tax Authority. The Israeli Tax Authority said that Bar Rafaeli claimed that since she was in a relationship with Leonardo DiCaprio, this income was tax exempt from having to be reported to the Israeli Tax Authority because she was living in the United States with her American Boyfriend. The Tax Authority didn't buy her story and said that her claims of tax exemption were "invalid" because the couple had never officially married.

To add even more fuel to her legal fire, Reaeli is also facing a serious perjury charge that is linked to a seperate June 2017 court testimony in which she fought other fraud acusations brought to a seperate June 2017 court testimony in which she fought other fraud accusations brought fourth by the Israeli Tax Authority. According to a local newspaper, the Times of Israel, she has also been accused of creating "shell companies" abroad and opening foreign bank accounts to hide other unclaimed earnings. Media

reports state that the supermodel could be charged seperately in this case, along with the new charges of tax evasion.

In addition to her own legal woes, Refaeli's family members, which include her mother Tzipi Refaeli, are also in the legal hotseat as well. They are suspected of failing to report nearly \$800,000 in kickbacks and commissions they received from her daughter's agent and are accused of depositing those funds into foreign bank accounts registered to Bar Refaeli of her "shell companies", in which Bar Refaeli set up herself.

Her parents, Tzipi and Rafi are also accused of money laundering by declaring to Israeli authorities that they were the sole beneficiaries of those bank accounts, when in all actuality, Bar Refaeli was the beneficiary. Furthermore, her mother Tzipi, is also suspected of providing false tax reports to authorities, specifically regarding recent living arrangements regarding her daughter. Authorities claim that her mother had rented two luxury apartments in Tel Aviv under her own name and said she was living at the apartments, when in reality, Bar was secretly living back and forth between the two apartments, hiding out from tax authorities.

This isn't the first time the supermodel has made news headlines for alleged unethical activities. She sparked controversy back in 2003 when she avoided two years of mandatory military service by marrying a friend of her father's- only to divorce him a short time later and skip out on her mandatory military duties.

Israeli tax laws require all Israeli citizens to pay taxes on any and all income earned from within Israel or abroad. Meanwhile, non-residents are only required to pay taxes on money made in Israel. The supermodel, whom is undoubtable one of Israel's most recognizable faces, has denied all allegations.

You now may be thinking to yourself, "I'm no

supermodel that has millions of dollars to hide from the government, so how does this story relate to me?"


