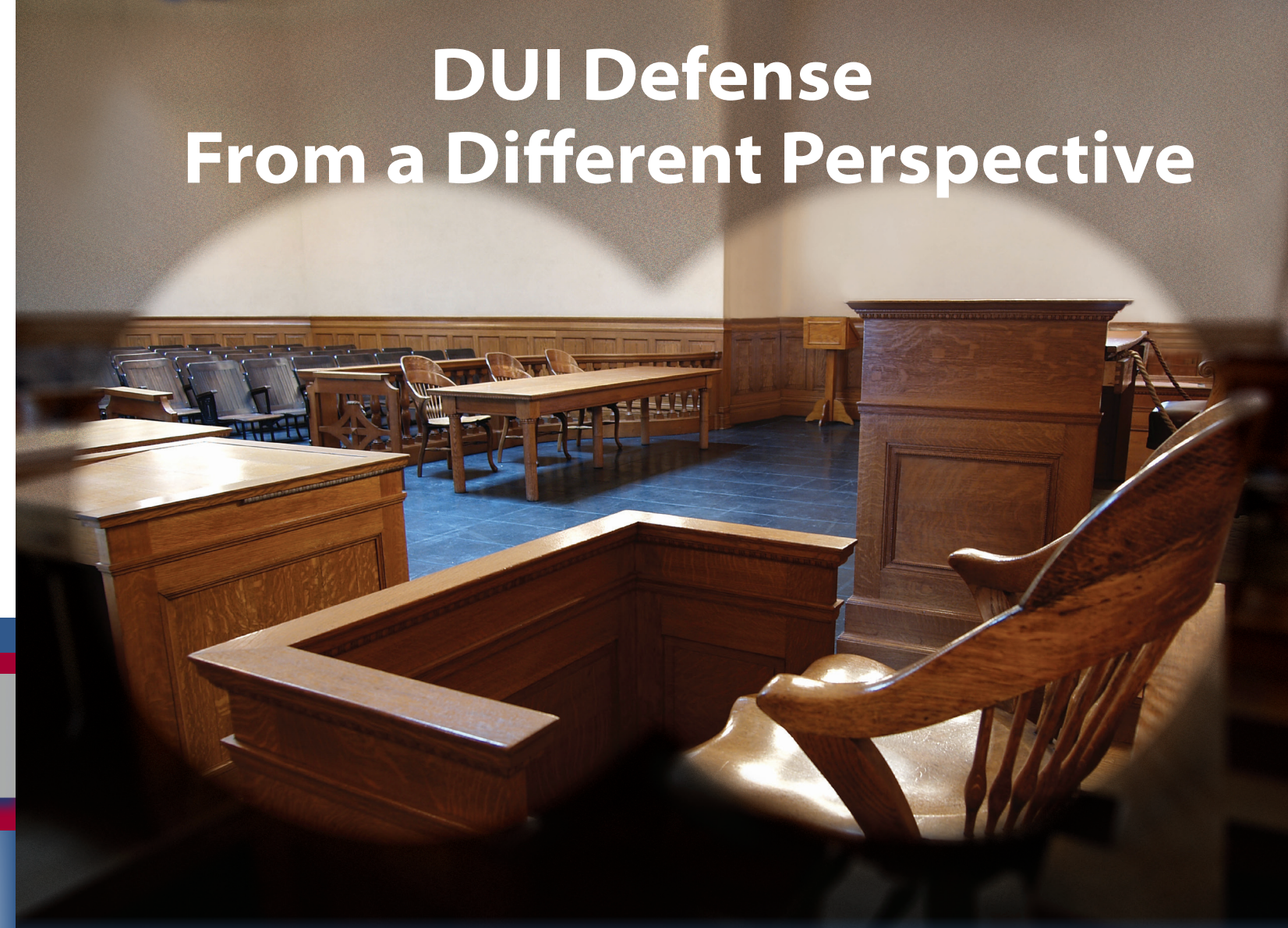

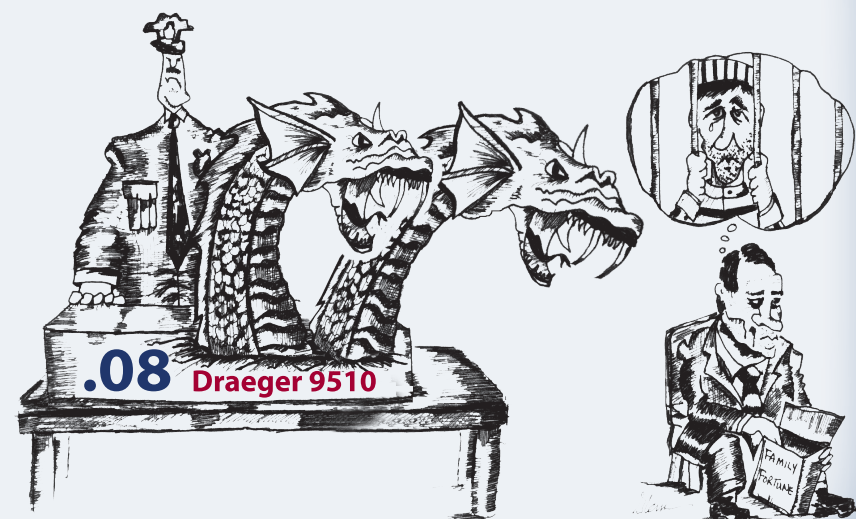

WILLIAM KIRK, has been with Cowan Kirk Kattenhorn since 2000 practicing exclusively in the area of DUI and BUI Defense. Named a *Super Lawyer* by *Washington Law and Politics* every year since 2003, Bill currently serves as the President of the Washington Foundation for Criminal Justice. He has been recognized as one of *Washington’s Top 25 Defense Attorneys* on two separate occasions. He currently serves on the Board of Regents to the National College for DUI Defense and is Board Certified by the National College. A regular speaker at this seminar, Bill has lectured in over a dozen states in the area of DUI Defense.



JONATHAN RANDS, Bellingham, is among the first WA State defense attorneys to handle Draeger cases in DOL and court settings. Prior to its use, Jonathan has been researching and preparing for the Draeger’s arrival. He educates himself to the highest level to achieve the best results possible for clients and is NHTSA qualified to administer roadside sobriety tests, and is ARIDE qualified. A past chair of WSBA Criminal Law Section & Criminal Justice Institute, and WACDL Public Education Ctte., Mr. Duarte has taught trial practice in Botswana, Kenya & Mexico. On the faculty of NITA & the Trial Lawyers College (founded by Gerry Spence), he teaches trial advocacy at UW School of Law, lectures at legal ed. programs and appeared on NW Cable news & radio programs as an analyst. Francisco is dedicated to helping the injured and individuals accused of DUI and other crimes.



SCOTT ROBBINS, practicing law for nearly 30 years, for the first 10 was the Mercer Island Public Defender where he took countless late night phone calls and 1000’s of cases (give or take a few). Scott has defended people accused of DUI all around Wa State. In 1999, he was the recipient of the first ever Creative Advocacy Award by the WFCJ. CHRISTINE JACKSON has been a public defender since 1990 and is currently one of the misdemeanor supervisors at The Defender Association Division of the King County Dept. of Public Defense. Over the years, Chris has represented adults charged with misdemeanors and felonies and clients detained for traditional civil commitment and under the “sexually violent predator” law.” She has handled appeals from misdemeanor convictions, writs of habeas corpus and other extraordinary writs. Chris served as the misdemeanor practice expert in the successful civil rights lawsuit challenging the constitutional adequacy of the public defense systems for the Cities of Burlington and Mt. Vernon.



ANDY ROBERTSON, in criminal defense since 1998, started as the Snohomish Co. public defender. Now she, with husband Ryan Robertson, has defended well over 1000 persons of DUI, misdemeanors, and felonies.
