SUMMARY:

Northwest Immigrant Rights Project (NWIRP) seeks a bilingual (preferably Spanish-speaking) attorney to provide direct representation and other forms of legal assistance to individuals pursuing various forms of immigration relief. Initially this position will be based in the asylum unit of NWIRP's Seattle office, with focus mainly on providing assistance to individuals seeking asylum and related forms of immigration protection. The position may shift to another unit within NWIRP's Seattle office, and the staff attorney will continue to provide immigration representation to NWIRP clients specific to the particular unit's focus.

The attorney will provide legal assistance to community members through: (1) direct representation; (2) individual consultations; (3) case referrals to pro bono attorneys; (4) self-help assistance in the form of community workshops; and (4) community education. The attorney will focus on representing individuals seeking asylum and related protections, but may work on other immigration matters.

Beginning annual salary is \$64,201 for a licensed attorney with no experience and is higher for attorneys with specific types of experience. For example, for someone with 10 years of non-profit immigration attorney experience, the annual salary would be \$87,624; 20 years = \$103,889.

NWIRP is proud to be a unionized employer, and this full time position is covered by NWIRP's Collective Bargaining Agreement. NWIRP offers a generous benefits package, including 100% of premiums for excellent health, vision and dental plans; 3% employer retirement contributions; disability/life/AD&D coverage; annual leave of 16 paid vacation days, 13 paid holidays, 12 paid health-related days; 12 weeks of paid parenthood leave after 6 months of employment; and partially paid sabbatical after 6 years of employment.

- Provide direct representation to clients before the U.S. Citizenship and Immigration Services, Immigration
 Court, the Board of Immigration Appeals, other federal agencies, and federal courts
- Conduct case analysis to determine eligibility for asylum and related protections
- Provide information on asylum law and process and pro se (self-help) legal assistance to individuals
- Review intakes to identify cases for referrals to pro bono attorneys
- Conduct intakes and individual consultations
- Maintain a working knowledge of significant policies, laws, and trends in immigration law, particularly as it impacts asylum seekers, asylees, and refugees
- Engage in NWIRP's outreach, community and legal education, and development efforts
- Provide case support to other staff members on asylum and related matters
- Perform related administrative tasks, such as case tracking and management, and other tasks as required and directed by supervising staff
- Participate in NWIRP's outreach, community education and development efforts
- Perform other tasks as required and directed by supervisory staff

Physical demands: While performing the duties of this job, the employee is regularly required to sit, stand, and walk; use hands to finger, handle, or feel; reach with hands and arms; talk and hear; and utilize a phone, computer, keyboard, pen, and paper. **Emotional demands**: While performing the duties of this job, the employee is regularly required to discuss topics including, but not limited to, discrimination, domestic abuse, and violence.

- Admission to the bar of any state in the U.S.
- Demonstrated commitment to advancing and defending immigrant rights and willingness to support NWIRP's mission, vision, and values
- Strong writing, communication, interpersonal, and organizational skills
- An ability to provide survivor-centered, trauma-informed, and culturally competent legal assistance to crime survivors
- Fluency in English and Spanish strongly preferred
- Strong ability to work independently
- Proficiency in use of web-based software, MS Word, and MS Excel
