Membership

Membership is open to any local government legal or governance officer working within a Local Authority (whether directly employed by the Local Authority or engaged through an agency or other similar arrangement), including but not limited to Monitoring Officers and their deputies, solicitors, barristers, legal executives and licensed conveyancers, and any trainee of any of them, but EXCLUDING any solicitor in private practice unless they:

- (a) practise on their own account, neither employed by nor in partnership with anyone else; and
- (b) undertake work solely on behalf of Local Authority clients.

There are 6 classes of membership:

- **Full Membership** - open to persons meeting the above qualification.
- **Limited Membership** – Free membership open to persons meeting the above qualification but with limited benefits (see below)
- **Past Service Membership** – open to former full members who have since retired or are no longer in work.
- **Associate Membership** – open to:
 - (i) former ACSeS past service members on 1 April 2013.
 - (ii) former monitoring officers or heads of legal at a local authority, who were members of ACSeS, SLG or LLG for the 3 years preceding them leaving that local authority and who are now in work elsewhere; or
 - (iii) other persons who, in the Boards absolute discretion are thought likely to make a significant contribution to the work of LLG.

- **International Membership** – open to any person meeting the requirements of the Board for this class of membership.
- **Honorary Membership** - former honorary members of ACSes or SLG and those granted honorary membership of LLG by the Board.

Benefits of membership

Full membership of LLG provides the following entitlements:-

- To receive notice of, attend, speak and vote at general meetings of LLG, branch meetings, special activity area meetings, regional special activity area meetings.
- Activity area meetings and meetings of any other national groups from time to time.
- To receive weekly and other LLG bulletins and material.

Past service membership and Associate membership of LLG provides the same entitlements as above, excepting that eligibility to stand for office with the Company is subject to the prior written consent of the Board in its absolute discretion.

Limited Membership provides the following entitlements:-

- To receive notice of, attend and speak (but no entitlement to vote) at:
 - General meetings of the company, branch meetings, special activity area.
 - Meetings, regional special activity area meetings and meetings of any other.
 - National groups from time to time.
- Access to the company's website (excluding any "members' only" pages).
- Discounts on selected [LLG Legal training](#) events.

International membership provides the following entitlements:-

- To receive any bulletins from the Company.
- Access to the Company's website, including any "members' only" pages.

Honorary membership provides the following entitlements:-

- To receive notice of, attend and speak (but shall not be entitled to vote) at:
 - General meetings of the company, branch meetings, special activity area.
 - Meetings, regional special activity area meetings and meetings of any other.
 - National groups from time to time.
- To receive any bulletins from the company.
- Access to the company's website, including any "members' only" pages.

Membership subscriptions

There is a direct benefit to local authorities if their staff are actively involved in relevant professional associations. We therefore encourage local authorities to pay membership subscriptions on their behalf. A single 'group fee' subscription payable by a local authority enables full membership to all its employees who meet the criteria for full membership.
