We represent the Peel District School Board and its representatives.

We are writing to you with respect to your articles on Life Site News by Peter Baklinski entitled: "Lesbian: I use math class to teach young kids about homosexuality so I can 'hide' it from parents" (<https://www.lifesitenews.com/news/lesbian-i-use-math-class-to-teach-young-kids-about-homosexuality-so-i-can-h>) and "Lesbian teacher: How I convince kids to accept gay 'marriage', starting at 4-years-old" (<https://www.lifesitenews.com/news/lesbian-teacher-how-i-convince-kids-to-accept-gay-marriage-starting-at-4-ye>).

We further note that your articles are cross referenced in various other articles, including the article of Steve Weatherbe, also on Life Site News, entitled: "Why Kathleen Wynne's claim that parents can 'opt out' of sex-ed is an utter farce" (<https://www.lifesitenews.com/opinion/why-kathleen-wynnes-claim-that-parents-can-opt-out-of-sex-ed-is-an-utter-fa>) as well as many other sites by other providers.

As you will be aware, in these articles, you have published images of these Board representatives, as well as images, videos and audio of minor children, who are students of the Board, without the appropriate consents, in breach of privacy laws. As noted, Life News was requested to cease recording at the workshop, and it was therefore, made clear to Life News at the time, that such recording, or the distribution of same, was not legally permitted.

In your articles, you have made inappropriate, aggressive and hateful comments regarding Board representatives which challenge the professionalism of these individuals. Further, your comments can be viewed as a public incitement of hate.

The Board and the individuals impugned take the position that these communications are defamatory and further have incited hateful responses which call the safety of the individuals into question. This letter serves as notice that you must immediately cease and desist such communications, and remove from the Life Site News website immediately all posting and images of Ms. Strong and Ms. Gunn (**including your publication on the internet of images of minor students of the Board**), failing which the Board and individuals will take immediate court action to restrain you without any further notice and you will be held responsible for all damages and costs.
