These Terms of Use govern your access to and use of iTeach.world and any related products, content, services and associated software and tools (collectively, the “Services”). These Terms of Use have been prepared in the English Language and this English version shall be controlling in all respects and any non-English version of these Terms of Use is solely for accommodation purposes. iTeach.world is owned and operated by WebRoom Education, Inc. a Delaware corporation (referred to as “WebRoom Education”)

1. You Must Accept These Terms to Use the Site

WebRoom Education provides the Services to you subject to these Terms of Use. Please read these Terms of Use carefully. If you do not accept these Terms of Use or you do not meet or comply with their provisions, you may not use the Services. Whenever you use the Services you are agreeing to these Terms of Use. If you do not agree to these Terms of Use you should not use the Services. References to “you” and/or “your” in these Terms of User refers to the individual who is using or accessing the Services or is registered and/or has provided a credit card or other payment mechanism for the Services either directly with WebRoom Education, iTeach.world, or through a third party.
