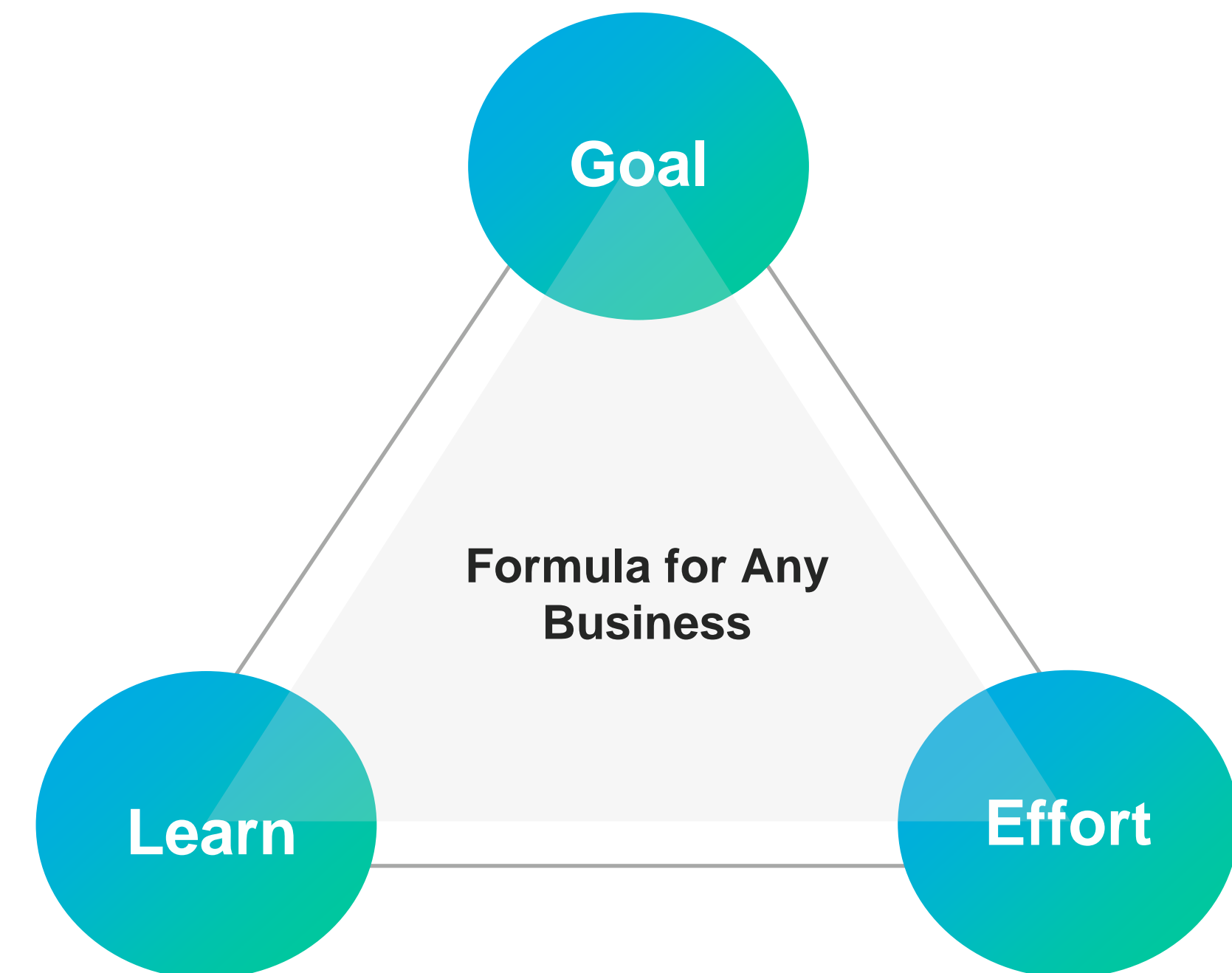

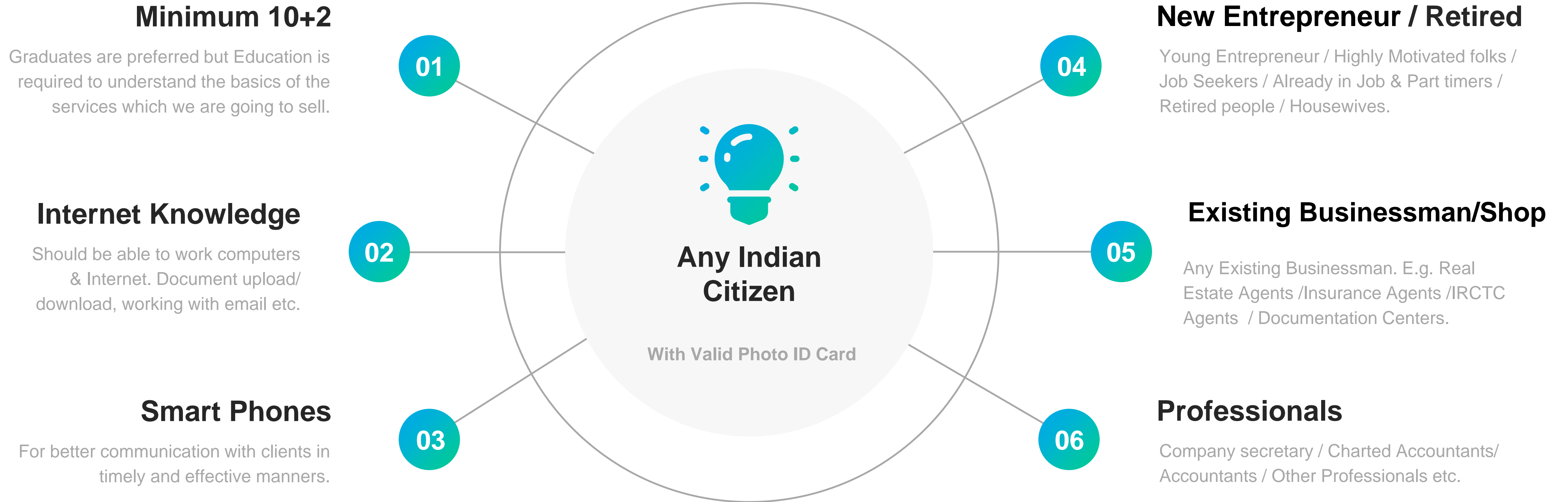

One time Income

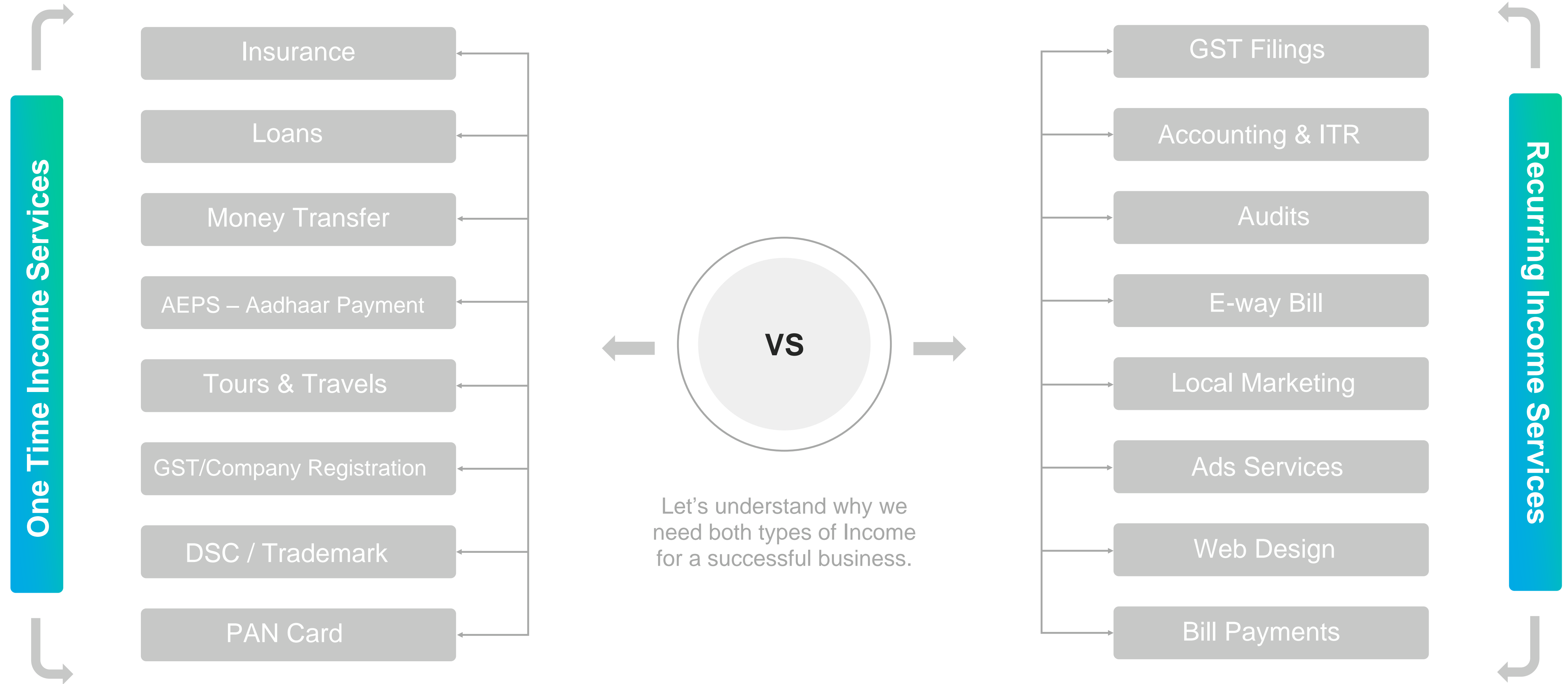
- Most of us are always behind income which is temporary in nature and used in day to day expenditure.

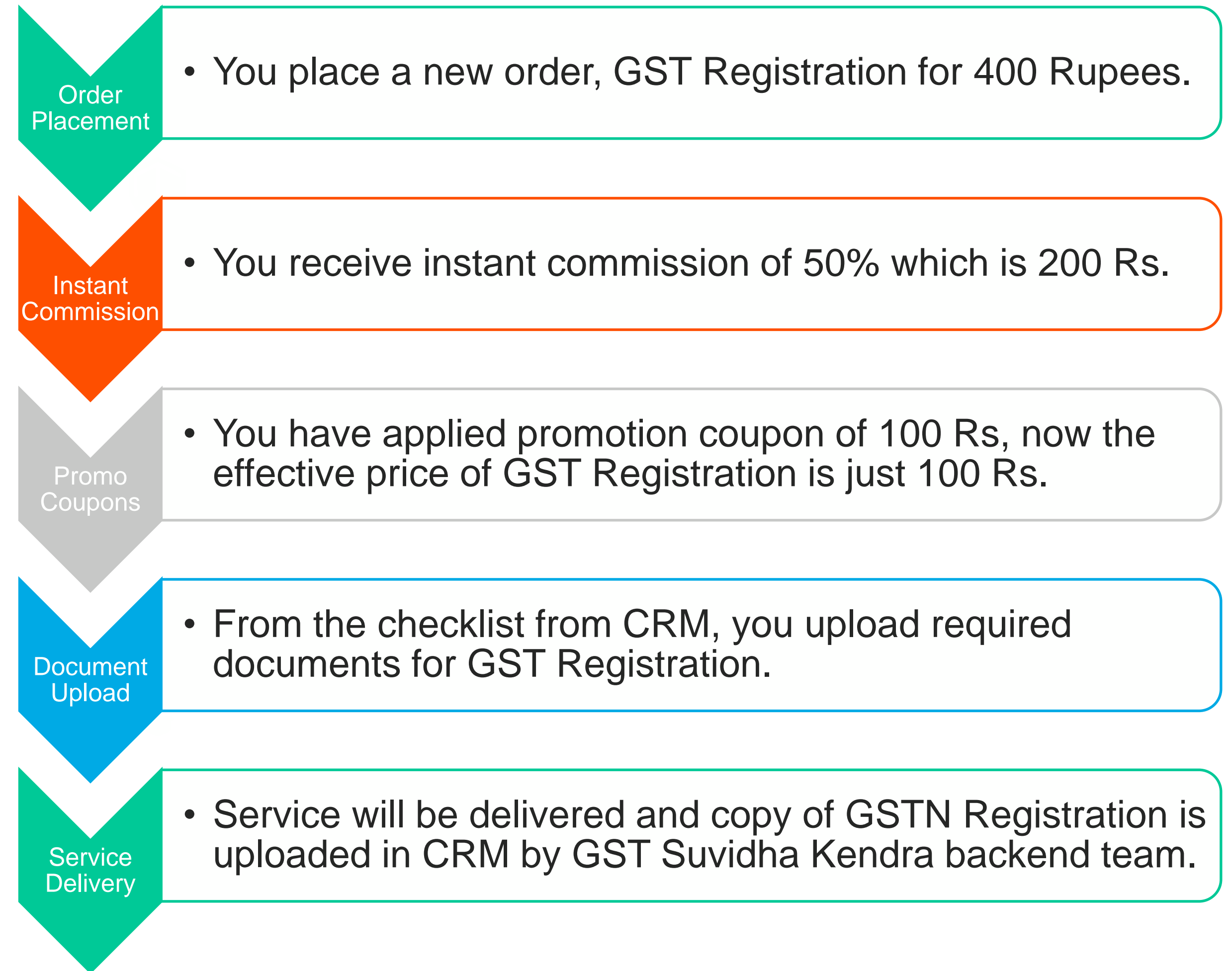

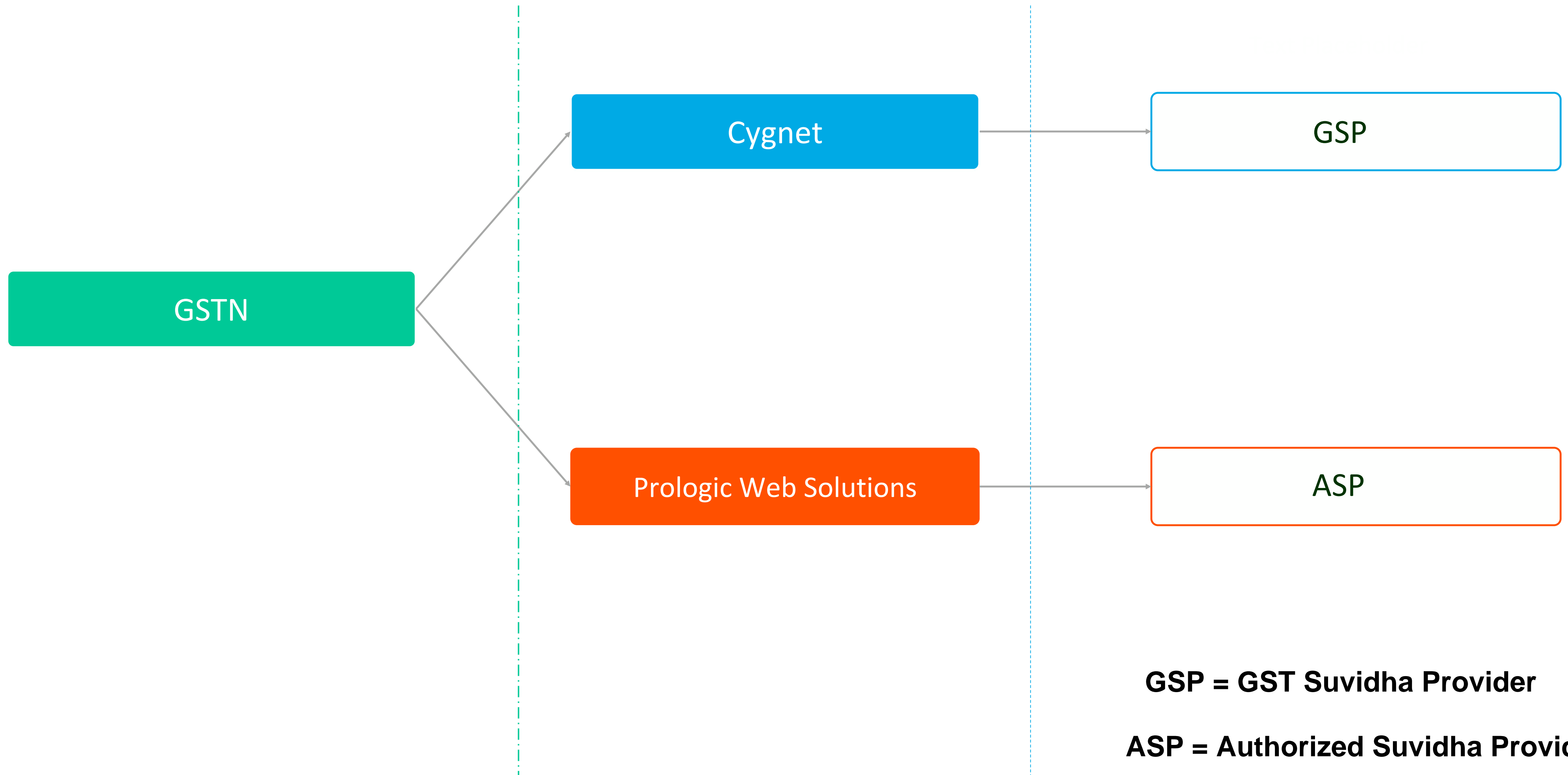


Real Time Calculation of Income

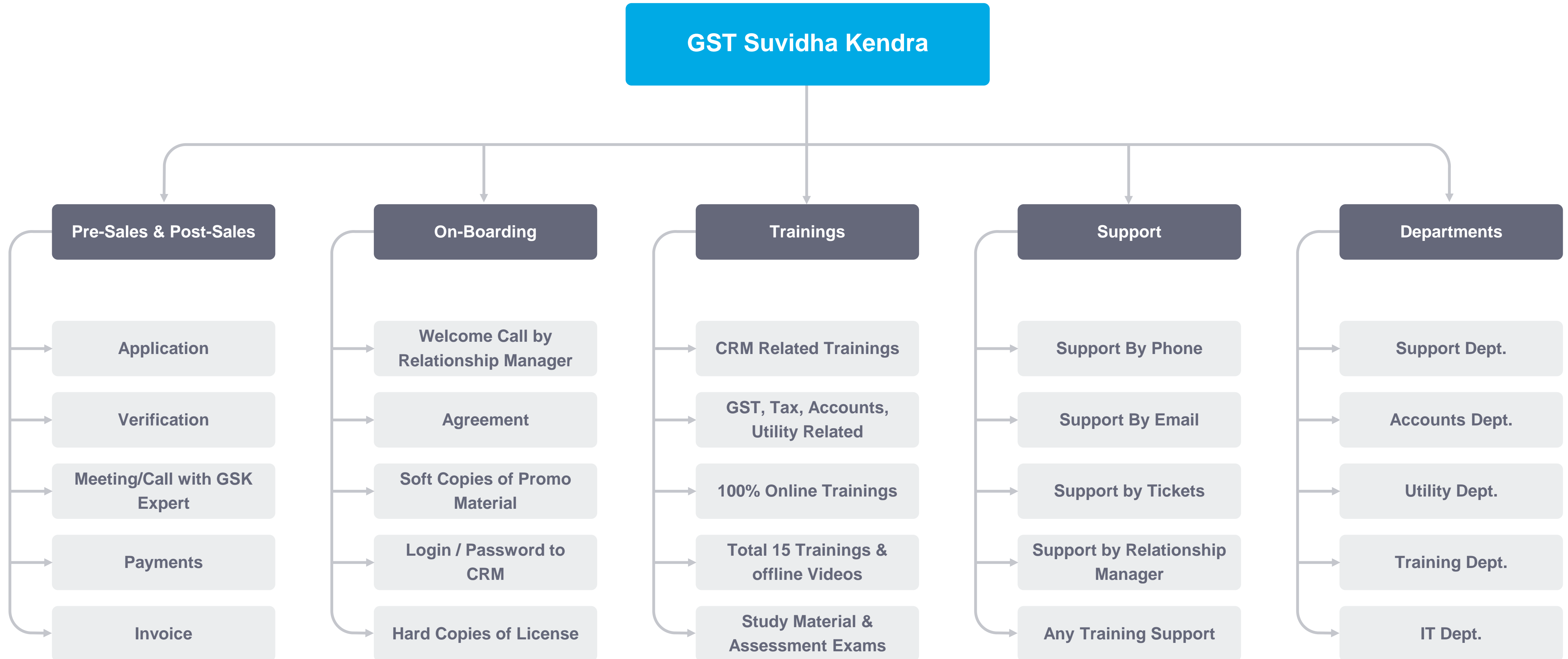
