- 1. NCR-SARE Research Project*—awarded, contract status (Kaderly, Lehnhardt)
 - Ed Kaderly's grant proposal was accepted and approved. Once the contract is received, LSRWA board approval will be needed to help support the project activities, including posting results to the LSRWA website and to help sponsor field days.
 - 1 season of sampling will be needed. Grande will pay for and send off the samples collected by several volunteers.
 - Ty, Pat, Susan and Ed will meet to discuss sampling methods and protocols on the 6-8/ sampling sites within each of the three impaired stream basins selected for the project: Juda Branch, OK Creek, and Spring Creek.
 - Bob, Pat, Ty, and Susan will work together to get WAV site designations, etc.
