Deposit Deadlines: Fall - July 1 | Spring - December 1

Remaining Balance Deadlines: Fall - August 1 or before travel | Spring - January 2 or before travel

If the student is accepted after the deposit deadline, the deposit should be paid as soon as possible after acceptance. The deposit may be refunded if the student is unable to attend due to documented visa denial or another documented circumstance approved by Ecclesia College before the student travels to the United States or begins enrollment. Payments should be made through Flywire. After payment is submitted, the student should send a copy of the payment receipt to choward@ecollege.edu.
