








General Updates

Board Vote - One-Year Extension to Exclusive Rigging Services Agreement

The Massachusetts Convention Center Authority (the "Authority") entered into an Agreement with JCAL Pro for Exclusive Rigging Services at the BCEC and the Hynes on January 1, 2020 (the "Agreement"). The term of the Agreement commenced on January 1, 2020 and expires on December 31, 2023. The Authority has the right, in its sole discretion, to extend the Agreement for two, additional, one-year periods commencing January 1, 2024, through December 31, 2024, and January 1, 2024, through December 31, 2025.

When the Authority sought the Board's approval of the selection of JCAL Pro for the Exclusive Rigging at the BCEC and the Hynes, the Authority noted the following: JCAL's exceptional business partnership with the Authority since 2005; JCAL's inclusive and diverse workforce to include a mix of both women and minority leadership in management roles and the participation of sub-contractors who meet Executive Order 565; and, JCAL's proven track record working extremely well with Authority personnel, the labor force, and other outside service partners such as Projection, ABM, and Levy. JCAL has continuously provided strong value to the Authority and its customers.

During the COVID Pandemic, JCAL did not close its in-house office and was a resource for the Authority when needed. JCAL assisted in support of the Boston Hope Field Hospital at the BCEC and fulfilled equipment requirements for day-to-day hospital activities. Moreover, JCAL continued to communicate with Authority customers regarding their event needs.

Much like the Authority's other contract partners, JCAL took a heavy financial hit during the Covid Pandemic, with significant impacts in year one of the current contract. In recognition of the impact that the COVID Pandemic had on JCAL, the Authority is seeking to add a fourth year to the base contract, extending the overall term to December 31, 2026, which the Authority can exercise in its sole discretion.

The Administration, Finance and Personnel of the Massachusetts Convention Center Authority recommends that the full Board adopt the following vote:

VOTE:

The Massachusetts Convention Center Authority hereby authorizes the Executive Director to add a fourth year to the base agreement, resulting in a one-year extension, at the end of the original contract commencing January 1, 2025, through December 31, 2026, which the Authority can exercise in its sole discretion.

Network Environment Overview

The MCCA Network consists of two main business operational functions: the Internal Corporate Network and the External Show Network.

Internal Corporate Network

The internal corporate network handles the network traffic of users such as MCCA employees and its contractors and all its business operations required devices such as Servers, IP Camera's, Telephones, HVAC devices, Digital Signage, Lighting System & Audio System.

External Show Network

The external show network handles the network traffic for all Exhibitors and Attendees who occupy the event space and generates revenue for the MCCA.

The Internal and External Networks are deployed with a Core, Distribution and Edge Hardware Architecture with network security enforced through firewalls for all traffic.

Current Juniper Support Maintenance Agreement

- The Current Juniper Support Maintenance Agreement is active until December 11, 2022. The current agreement covers all Juniper Network equipment that is up for renewal.
- The Support agreement covers:
 - Juniper Hardware consisting of Firewalls
 - Core Routers
 - Distribution Switches
 - Edge Switches
 - All other Juniper equipment
- All Juniper supporting Software and Licensing:
 - Security Software AppSecure

Juniper Support Maintenance Agreement

The Juniper Support Maintenance Agreement which begins on December 12, 2022 is a renewal of all Juniper equipment that is coming out of warranty. The support and maintenance contract for the Network equipment is procured through the state of MA Contract ITT72. The MCCA has historically worked with Integration Partners over the past 7 years who are an Elite level Juniper Partner.









PROPOSED - STATE ST LOOKING SOUTH
