II. BOARD VOTE - JUNIPER SUPPORT MAINTENANCE AGREEMENT

Robert Noonan, Chief Information Security Officer, made a presentation to the Board seeking the renewal of the Juniper Support Maintenance Agreement.

The Authority is requesting the renewal of the Juniper Support Maintenance Agreement to ensure network stability and security for the BCEC, Hynes, and Boston Common Garage network infrastructure.

The Authority network consists of two main business operational functions: the Internal Corporate Network and the External Show Network. The network infrastructure consists of Core Routers, Distribution switches, Edge switches and Firewalls for the BCEC, Hynes, and Boston Common Garage.

The Juniper Support Maintenance agreement term begins on December 13, 2023, and ends on December 14, 2024.

The Juniper Support Maintenance Agreement falls under the ITT72 State Contract and adheres to the State contract pricing. In conjunction with the Authority's procurement team, we are requesting to renew our Juniper Support Maintenance Agreement with the licensed reseller ConvergeOne in an amount not to exceed \$459,810.77.

III. REPORT OF EXECUTIVE COMMITTEE

Executive Committee Chair Emme Handy proposed that Gloria Cordes Larson be considered by the Board to fill the role as an interim executive director to allow the Board to conduct a search for the vacant Executive Director position.

1. Board Vote - Succession Planning for Authority Executive Director

Gloria Cordes Larson served as the Chairwoman of the Board of the Authority from 1999 to 2010. Under her leadership, the organization oversaw the renovation of the MassMutual Center in Springfield and the construction of the Boston Convention and Exhibition Center, which opened in June 2004.

In 2007, Ms. Larson was named president of Bentley University by the board of trustees and served as president until June 2018.

Ms. Larson was the first woman to serve as Chairwoman of the Board of the Greater Boston Chamber of Commerce and continues to serve on the Chamber's Executive Committee.

A motion duly made and seconded, the Board voted unanimously to approve by roll call vote as follows:

VOTE:

The Massachusetts Convention Center Authority hereby appoints Gloria Cordes Larson to fill the role as interim executive director of the Authority, effective as of January 3, 2024, to exercise all powers and directs that she undertakes all duties and obligations of Executive Director as provided by law, the by-laws of the Authority and any resolution or other vote of the Authority, heretofore adopted, including but not limited to St. 1982, c. 190 § 31 et. seq.; St. 1997, c. 152; and, St. 2014, c. 195, and to hold such position until such time as an Executive Director is appointed pursuant to St. 1977, c. 152, §24 or as is otherwise provided by vote of the Authority. The Chairwoman of the Authority or such designee as the Chairwoman shall determine, is authorized, and directed to enter into, on behalf of the Authority, a contract with Gloria Cordes Larson to serve as an interim executive director of the Authority, upon the terms and conditions deemed appropriate by said Chairwoman.
