With the wheat market being so weak, CoMark is probably going to sit on the wheat in the bunkers until summer or fall of next year to take advantage of some better markets. In my travels back to my old home, there is no shortage of wheat on the ground as other coops have had to make the decision to pile wheat in order to make space for fall crops. The wheat situation going forward will definitely be interesting to watch as farmers are making decisions whether to plant wheat for next year or not given the low wheat price.

We are excited here at Valley Coop to open up a new chapter on our agronomy department. Further on in this newsletter, you will be able to read about our new agronomist that we will be bringing on. Our intention is to provide this service free of charge to our members that use our custom application and purchase their chemicals and fertilizers through Valley Coop. The board has been instrumental in identifying this need for the area and we hope that this service is well utilized by our growers.

I do want to wish all of the coop members and employees a Happy Thanksgiving and a Merry Christmas. I have felt truly blessed by this job that I took over in May and know that my family will love this area as well.

OFFICE CHATTER

Domestic Production Activities Deduction (DPAD) letters were mailed out to stockholders in November - the envelopes were stamped “Important Information – Open Immediately.” The DPAD **credit** is based on your March 31, 2016 Patronage business with Valley Co-op, Inc. This amount will also be printed on your Substitute 1099 that will be mailed out in January 2017.

Substitute 1099’s will be mailed out no later than January 31, 2017 and will be stamped “Important Tax Return Documentation Enclosed.” It will include Patronage and/or Investment Interest, along with the Production Activities Deduction (DPAD). Please consult with your tax advisor for further information on the DPAD and how it applies to your farming operation. Investment Interest amounts under \$10.00 will NOT be reported by Valley Co-op, Inc. ******There will also be an amount listed on the Substitute 1099 designated as “Per Unit Retain.” This is your grain sales for 2016. We will include documentation that lists your grain sales with a note explaining the Per Unit Retain reporting instructions.

*****Deferred Grain Contracts paid JANUARY 2, 2016 WILL NOT be listed as “Per Unit Retain.” Rebecca will send out tax reporting documentation for this information no later than January 31, 2017. The envelope will be stamped “Important Tax Return Documentation Enclosed.” CoMark Grain Marketing (CGM) will mail Deferred Grain Interest Substitute 1099’s on amounts \$600 and over.***

Please verify your social security number when you receive the 1099’s and contact me at the Main Office –620-221-4343 or 1-800-221-4346 if there are corrections to be made! For those patrons that received an Equity Retirement payment in October --- this payment will NOT be reported on a 1099 as a 1099 PAT was issued to each patron in the year that the equity was earned.

Our fall harvest is all but finished up at this point with the exception of just a couple hundred acres of double crop milo yet to receive. We had an outstanding bean crop this year that almost doubled previous records! The bountiful moisture and ideal growing conditions made for some exceptional yields this season ranging from 40-70 bushels/acre and the double crop beans were not far behind in terms of yield and quality which is fairly unusual for this part of the country. With the large amount of total bushels we handled this year bin space got pretty tight at times but we managed to keep the doors open the whole time without any down time due to space constraints. A big thanks to our marketing group for keeping the logistics in order and trucks rolling out so we were able to handle this record crop.

On another note, now is a good time to be discussing crop rotations and burndown/pre-emerge programs to get ahead of the pigweeds and other problem weeds that have been challenging the last couple of years. Please give us a call or stop by to speak with us about different chemical options that are available. Cranberry Cheesecake Fluff

12 oz. package fresh cranberries
1 $\frac{1}{2}$ cup sugar divided
8 oz. can crushed pineapple, drained
 $\frac{1}{2}$ cup walnuts

2 cups mini marshmallows
8 oz. cream cheese softened
2 cups heavy whipping cream

In a food processor or blender, combine cranberries, 1 cup sugar, crushed pineapple, and walnuts. Pulse until coarsely chopped without becoming mushy. Cover and refrigerate for an hour to let flavors blend.

In a medium bowl add the cream cheese and $\frac{1}{2}$ cup sugar and beat until smooth. Add the heavy whipping cream and continue to beat with the cream cheese until stiff peaks form. Fold the cranberries and marshmallows into the salad. Cover and refrigerate for at least 3-4 hours or overnight.
