**Barley Projected Price Discovery Period: Winter types projected price discovery period is August 15 – September 14 of the pre-harvest year, Spring types projected price discovery period is February 1 – February 28 (February 29 – leap year).

**Canola Projected Price Discovery Period: Fall Type Projected price discovery period is July 15 – August 14 of the pre-harvest year. Spring Type Projected price discovery period is February 1 – February 28 (February 29 – leap year).

**Corn for Grain Projected Price Discovery Period: Projected price discovery period is February 1 – February 28 (February 29 – leap year). Corn for Silage Projected Price – A price determined by RMA and released by January 31 of the harvest year.

**Soybeans Projected Price Discovery Period: Projected price discovery period is February 1 – February 28 (February 29 – leap year).

**Wheat Projected Price Discovery Period: Winter and Spring types projected price discovery period is August 15 – September 14 of the pre-harvest year. Winter type references CBOT with PME basis adjustment; Spring type references MGE. Exception for Klamath County (41035) price discovery for spring types will be Feb 1 - Feb 28 (February 29-leap year)

***Barley Harvest Price Discovery Period: Harvest price discovery period is August 1 – August 31 in all states except Alaska; Alaska harvest price discovery period is September 1 – September 30.

***Canola Harvest Price Discovery Period: Fall Type Harvest price discovery period is August 1 – August 31. Spring Type Harvest price discovery period is September 1 - September 30.

***Corn for Grain Harvest Price Discovery Period: Harvest price discovery period is November 1 – November 30. Corn for Silage Harvest price – A price determined by RMA that is equal to the projected price.

***Soybeans Harvest Price Discovery Period: Harvest price discovery period is October 1 – October 31.

***Wheat Harvest Price Discovery Period: Harvest price discovery period is August 1 – August 31. Winter type references PME; Spring type references MGE.

~Rapeseed prices - Rapeseed is not traded on any Commodity Exchange. However, revenue protection is still considered to be available and the projected and harvest prices will be established by FCIC in accordance with the Commodity Exchange Price Provisions. The result of this action will allow the producer to insure both canola and rapeseed under revenue protection. With both canola and rapeseed insured under revenue protection the producer can qualify for a whole-farm unit. However, rapeseed will not have the benefit of the harvest price moving independent of the projected price as it may for canola. Projected prices for fall and spring types of rapeseed are determined by RMA and released prior to sales closing dates. Harvest price for the applicable type is set equal to the projected price.

~~Certified Organic Corn (Grain) or Soybeans - For acreage insured as certified organic, the Projected Price and Harvest Price will equal the respective Projected Price and Harvest Price as defined within the Commodity Exchange Price Provisions (CEPP) multiplied by a factor determined by RMA and published on www.rma.usda.gov.

\$Grapes – Optional Use of Contract Price // In addition to the maximum established price offered in the actuarial documents, producers may use the contracted price to determine the producer's amount of MPC coverage. This contract based price election will be determined using the producer's actual contract price. Eligibility requirements and further details are contained in the Special Provisions of Insurance.

^^The Malting Barley Endorsement (MBE) utilizes a (CBOT) soft red wheat price component to derive the projected price for any insured whose malt barley contract provides for a premium amount above or below a base price to be determined, and the base price is not determined by the acreage reporting date.

##Dry Peas - The projected prices for spring types will be announced after the fall sales closing date but no later than November 30th of the calendar year proceeding the crop year except for those types where the Dry Pea Revenue Endorsement offers coverage for price moment; these types are announced not later than the third business day of March.
