BULLS CONTROL ENERGY MARKETS


The price of oil dropped 300% on April 20, 2020 to a historical negative \$37 per barrel. A price war between Russia and Saudi Arabia coupled with the crash in demand due to Covid-19 had energy markets reeling. For a moment in time traders would pay you to take the crude oil off their hands! We all knew this market would not be held down; demand destruction from Covid-19 would slowly recover and OPEC+ would work out their differences.

The rate at which energy markets are recovering can be a bit startling. As I type, crude oil is around \$66 per barrel (see crude oil chart below), a level some thought would not be seen until summer driving demand was in full swing. However, energy markets have never taken a 'wait and see' approach. Long positions (betting crude oil would go higher) in crude oil began to rise in late 2020 as investors attempted to seize the opportunity of buying cheap crude oil once Coronavirus vaccinations became more of a reality.

Coronavirus was not the only topic fanning the flames of the crude oil price. First, new energy policies set by the Biden Administration has traders worried that the U.S. will rely more upon crude oil from other nations; leaving oil prices more vulnerable to geopolitical events. Second, southern states, namely the state of Texas, saw unseasonably cold weather bring their crude production to a screeching halt (Texas accounts for 41% of the nation's crude oil production according to the Energy Information Administration). Thirdly, OPEC nations decided that there would be no increase in supply and production cuts would be adhered to; fearful they would oversupply the market to quickly without allowing demand to recover. Even Saudi Arabia plans to continue their extra 1 million barrel per day cut, which is above and beyond the OPEC+ agreements.

Needless to say, energy markets have had plenty of headlines to rally on! \$75+ crude oil this summer seems very reasonable at this point as industry experts believe oil demand will return to normal by August as demand slowly recovers to pre-pandemic levels. Continue to keep barrels full and have contracts in place during your higher demand times to achieve this. Hindsight tells us this should have been done a couple months ago but I believe the opportunity still exists to manage your risk by forward contracting.

The fertilizer market has been tremendously active since the fall. Most products have nearly doubled or more than doubled in price since the late summer. The increase in price could easily be explained away by saying grain prices have also risen. However, the increase in some of the commodities is a little more complicated. One reason is that the industry is trying to restock after having a record fall of fertilizer placement across most of the Midwest. The phosphorus market was the initial fertilizer to make substantial increases starting in early fall because of an anti-dumping lawsuit that Mosaic filed. That lawsuit affects two of the world's largest exporters of phosphorus, Morocco and Russia. The Commerce Department was originally supposed to release their findings back in November but as I write this article, we still do not know what the countervailing duties will be. Since countries don't know what the exact penalties will be, very few phosphorus imports have arrived since August. About 50% of our phosphorus needs are imported and with the fear of the countervailing duties still lingering the best way to get imports to the U.S. is to outbid all other countries. The fact that the lawsuit is still not settled could make getting product this spring difficult. We historically sell phosphorus in the form of MAP but this spring we will also bring in DAP because it looks to be more attainable during the spring. Nitrogen fertilizers have also been moving higher in recent weeks. Once again part of the increase came because of higher grain prices but the largest increase recently is because of the cold weather that moved across the country. Many nitrogen plants had to shut down to curtail natural gas as it was needed to heat homes. When the plants are shutdown, they are cooled down with water which froze in the cold temperatures. It has taken weeks instead of days to get the nitrogen plants back up and running and some are still not performing. This has left the industry short thousands of tons of nitrogen just before spring. One way to make up for the lost tons is to import and to get imports to the U.S. in a short notice you must do what? You guessed it, "outbid all the other countries to get the barges pointed our way". In recent weeks we have had customers ask about locking in fertilizer for fall and the

In recent weeks we have had customers ask about locking in fertilizer for fall and the spring of 2022. At this time, it may seem like there is no downside in the fertilizer market other than grain prices going lower, however, as I have explained there are other reasons that need to be examined to understand the complete risk before locking in product that is

7-14 months away from usage.

One of the changes with the relabeling of dicamba on dicamba tolerant soybeans is the effect it has on the Endangered Species Act. The following information will give an explanation of guidelines and who it effects. It is our understanding that new counties can be added at any time making it important that everyone have some knowledge of the regulation.

The updated Environmental Protection Agency (EPA) label for XtendiMax® herbicide with VaporGrip® Technology, a restricted use pesticide, requires additional protection measures in 289 specific counties. In these specific counties, a 310-foot in-field wind-directional spray drift buffer and a 57-foot omnidirectional in-field buffer are required to protect federally listed threatened and endangered species. Non-sensitive areas, defined below, may be included as part of the buffer.

NONSENSITIVE AREAS: To protect federally listed threatened and endangered species, both a 310-foot infield wind-directional spray drift buffer and a 57-foot omnidirectional in-field buffer are required. If applying to dicamba tolerant soybeans with a qualified hooded sprayer, both a 240-foot in-field wind directional spray drift buffer and a 57-foot omnidirectional in-field buffer are required to protect federally listed threatened and endangered species. Please see the label for a link to the website(s) with your product's qualified hooded sprayers. The following areas may be included in the buffer distance composition when directly adjacent to the treated field edges: 1. Roads, paved or gravel surfaces, mowed grassy areas adjacent to field, and areas of bare ground from recent plowing or grading that are contiguous with the treated field. 2. Planted agricultural fields containing dicamba-resistant plantings of cotton and soybeans. 3. Areas covered by the footprint of a building, silo, or other manmade structure with walls and/or roof. Counties effected in Iowa and Minnesota are listed below;

Iowa: Allamakee, Cerro Gordo, Clayton, Delaware, Dickinson, Dubuque, Emmet, Hancock, **Howard**, Jackson, Kossuth, Osceola

Minnesota: Clay, Fillmore, Lincoln, Mahnomen, Murray, Olmstead, Pipestone, Polk, Pope, Winona

During the month of February, the agronomy team does a lot of training and year-in-review classes. The following is a picture of a slide I took during one of those sessions. The information was presented by Dr. Shaun Casteel and it is a plot that shows the difference in yield when adding some sulfur and nitrogen to soybeans. The interesting part is the difference based on planting date. The left column under yield is soybeans planted before May 12th and the right column is soybeans planted after May 12th but before June 8th. Without sulfur or nitrogen applied the yields are the same for the planting dates.



It looks to be a busy spring and summer for the Grain Department. Not only will we be moving a lot of grain, we will be communicating with our counterparts at Five Star to explore all the possible efficiencies of a combined company. After a successful vote this summer, we will work to integrate the two merging grain departments into one.

Farmers Win Coop currently serves 11 different communities with 12 grain elevator facilities. We have 4 locations in Minnesota; both in Fillmore and Houston counties. We also serve 3 towns in Howard and Winneshiek County in Iowa. Further south, 4 elevator locations are spread out in Chickasaw, Fayette and Bremer counties. All of these elevator locations can efficiently handle wet or dry corn and soybeans and have a combined storage capacity of over 15½ million bushels. With our trade territory spanning 100-miles from North to South we have access to many end users and with our Federal Grain License we can arbitrage between Minnesota and Iowa. Also, we can utilize semis over our entire territory from South to North to help out different locations at different times during the year. Farmers Win Coop also offers direct to terminal bids for our customers. Please call any of our locations or the Fredericksburg office if you have any questions on our direct grain program.

Spring is officially right around the corner. I love that the days are getting longer and the temperatures are climbing!

Right now, the market is primarily focused on the two things that happen every March: weather and planting intentions, along with tight ending stocks this year. Price volatility has been the name of the game in commodities for quite some time now. The expectation is this will continue as we await the March 31st Planting Intentions Report and watch the progress (or lack thereof) of bean harvest and safrinha corn planting in South America. Brazil has struggled with harvesting soybeans and planting second crop corn. Argentina has been dry while the high producing areas of Brazil have been receiving above-normal rainfall.

Economists at the 97th Annual Agricultural Outlook Forum estimated the US will plant 92 million acres of corn (up 1 million from 2019), 90 million acres of beans (up 6.9 million), and 45 million acres of wheat this spring. The estimated yield for corn was 178.4 bpa and beans 50.9 bpa, both closer to trendline than what was produced in 2020. Chicago futures and cash bids support this increase in acres. Farmers haven't seen prices like this since 2012, when the Midwest experienced a severe drought, and are incentivized to plant every acre they can. In our draw area specifically, fall was favorable for applying anhydrous so we expect most local farmers will stay with their normal crop rotation.

For your information: Governor Reynolds has extended the Public Health Emergency through April 6, 2021. This includes allowing trucks hauling corn and beans to exceed the 80,000 lb. weight restriction as long as they don't exceed 20,000 pounds on an individual axle, and their total weight does not exceed 90,000 pounds.

Direct Deposit, Text Messages & Email Services

Farmers Win Coop offers direct deposit grain payments for both elevator and direct delivered grain. Funds are generally available within 48 hours of processing the ACH. We then send a duplicate check copy along with the settlement sheets to your designated email address as a PDF file.

Grain contracts are also available to email directly and sign. Additionally, we have email and text message services available for elevator scale tickets and grain markets on a daily basis.

Forms can be returned to your local FWC location. If you just need to update your information, please contact your local FWC location or email grainaccounting@farmerswin.com.

Grain Hauling

As you are hauling grain, either into a location or direct to the terminal, be sure to communicate your intentions in a timely manner with office staff at our locations about what is to be done with your grain.

With direct to terminal delivered grain, be sure to put your correct information on the tickets which includes Farmers Win Coop plus either producer name or producer number. If you notice something is incorrect with a ticket, please notify the terminal prior to leaving the facility and/or notify your local FWC location. Double checking your tickets ensures that the producer, the hauler, and FWC all get paid in a timely manner.

House Receipt Storage

A friendly reminder, when grain is initially deposited on a receipt, the storage due will be charged at the end of the month the grain is placed onto the receipt. The minimum storage period will be billed upfront. This charge for storage will be due the month following deposit of the grain. After the minimum period, accrued storage is billed monthly.

Lastly, the grain team would like to introduce you to Beth Snyder. Beth works out of our Spring Grove location and will be helping with grain origination in our northern draw. Welcome Beth!

Rich Fravel Safety/Compliance

It's that time of year where equipment will be sharing the roads with motorists. Patience and courtesy for your farmers during this season. Here are some tips from Farm Bureau Insurance for when vehicles and large equipment are on public roads.

Road Safety with Farm Equipment

Sometimes, you have to take to the streets with farm equipment in tow. Other times, you might be in your car or truck and see a tractor on the road. In both cases, preventing accidents is everyone's top priority. Stay mindful of these farm equipment road safety tips when you're out and about.

Make Farm Equipment Visible with Lights and Flashers

Verify that all lights and flashers on your farm vehicle are working properly. Use warning flashers, flags, lights and slow-moving vehicle emblems on all equipment. Apply reflective tape to machines to improve visibility for motorists at dusk. Avoid traveling before dawn and after dusk if you can. If you need to drive during these times, ensure that headlights are working. Headlights help you see and be seen.

Remember Your Farm Vehicle's Size

Be mindful of the height of your farm equipment and avoid power lines, low bridges and other overhead obstacles. Check your towed equipment. All loads should be balanced and securely mounted.

Tip for Motorists

Don't pull in front of farm equipment and suddenly slow down. The tractor may be towing heavy machinery, making quick stopping impossible.

Be aware of slow-moving vehicles.

Expect farm equipment and tractors to travel at a much slower rate — between 5 and 15 miles per hour. Give tractors and combines plenty of room to operate. Expect them to take wider turns and even have to travel into both lanes to properly turn. Let's have a Safe Spring Season!













