June 18, 2018

SUBJECT TO CHANGE WITHOUT NOTICE!

1. Delayed Price and cash grain 13.5 moisture.
2. 3% per point shrink will apply on loads from 13.5 to 16.0 moisture.
3. Loads over 16.0 moisture will be subject to rejection.
4. If sold within 15 days of delivery – No DP charges
5. No open store available on wheat – DP only
6. Deferred Price Contract- \$.0015/bu/day to apply, from day of unload (4.5 cents/mo)

SCAB DAMAGE

15 cents from .1% to 1.0%
30 cents from 1.1% to 2.0%
45 cents from 2.1% to 3.0%
Additional 10 cents/point over 3.1%

VOMITOXIN

5 cents from 1.1 to 1.5 PPM
10 cents from 1.6 to 2.0 PPM
15 cents from 2.1 to 2.5 PPM
20 cents from 2.6 to 3.0 PPM
30 cents from 3.1 to 3.5 PPM
40 cents from 3.6 to 4.0 PPM
Plus 10 cents each ½ PPM over 4.0 PPM

Damage, F.M. & Scab Damage will be subject to Submitted Grades if suspect.

If Damage and Scab Damage is detected, a composite sample will be submitted to Lincoln Inspection Service from that farm to test for the damage and vomitoxin.
