1974

1990

1990 was a big year for us as we experience exponential growth and opportunity. The Green Camp location was purchased, and the Propane Division was started.



NAME CHANGE, AGAIN

2000

The name of the cooperative was changed from Marion Landmark, to the name we still call it today, Central Ohio Farmers Co-op, Inc.



ENERGY EXPANDS TO LIMA

2004

The purchase of Niedert Petroleum in Lima further expanded the reach of our Energy Division.



OILS & LUBES DIVISION STARTED

2007

The Oils and Lubes division was started. With this we are now able to service all of your lubricant, coolant and metal cutting coolant needs.



ENERGY EXPANSION

2009

We purchased BP route for Tiffin from Consumers Petroleum. Included in this purchase was the Card N' Go unmanned fueling station on Rt. 53 in Tiffin.

NEW HEADQUARTERS

2014

In 2014 we became a more substantial entity in grain as we purchased Bunge Facility in Marion, Ohio and it became a part of our Grain Department. The offices there also became our main headquarters. This purchase allowed us to triple the volume of our grain market.
