CORN

Storage: 24 cents per bu to 1/1/27
4.5 cents per bu per month

SOYBEANS

Storage: 30 cents per bu to 1/1/27
6 cents per bu per month

- Monthly storage charges prorated daily
- *DP Rates: Based on market conditions. Please call your local originator for current rates. Grain on DP cannot be applied to deferred sales contracts and must be sold at the nearby cash price.*

Drying & Shrink

Drying:

2.5 cents per ½ point

Shrink:

1.4% per point (.0014 per tenth)

Open Storage shrunk and dried to 14%

Spot/Contract shrunk and dried to 15%

****Location Specific DP shrunk and dried to 14%**

Shrink:

1.5% per ½ point above 13%

3% per ½ point above 15%

Above 15% subject to rejection

10 cent/bu discount on all loads above 18%

All contract and stored bu shrunk to 13%

Test Weight: 1 cent per pound 53.9-50.0

4 cents per point over 7.0%

Other Color(SBOC) 1 cent per point 1.1% to 10%

Above 10% subj. to rejection

Musty = 10 cents

Sour = 20 cents

Heating = 20 cents

COFO = 20 cents

Over 1% green/lima = 10 cents

Splits = 1 cent per point above 20% to 35%.

**Splits above 35% subject to rejection.*

Notes

-Grain from 2025 crop and prior remaining in elevator storage/DP will be charged a new minimum on 9/1/26.

-Bushels will be applied to open contracts first.

-Harvest grain must be designated for storage or sale within 7 days of delivery. Verify this designation with your Customer Service Team Representative. After 7 days, bushels will be put into storage where open storage rates will apply. *Bushels hauled to a non-FS Grain Facility do not qualify for the 7-day hold grace period.

-Post-Harvest, grain deliveries will be applied daily to open contracts. If no contracts are available, grain will be spotted at the value of that day's closing price unless other instructions have been given.

-Spot price for harvest bushels on hold is calculated using the basis from date of delivery and current futures price.

-All Delayed Price Later Contracts must be signed within 30 days of last day of delivery.

-New minimums will be applied on 9/1/27 for grain delivered and remaining in storage or DP, unless otherwise stated.
